4. **L1 Position – GETCO Project (Kisan Suryoday Yojana Phase II)-** for Supply, Erection, Testing & Commissioning of 66 kV S/C Shivalakha–Vajepar Line, having length of 30.3 RKM under Kisan Suryoday Yojana Phase II Scheme.
