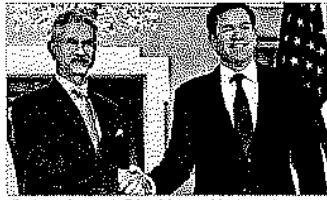

The investigation report reviewed by the Division suggests that the impact of the transaction will be to increase competition across the media and entertainment ecosystem, with benefits for American consumers and workers.

The Justice Department wrote in a statement, Paramount CEO David Ellison's father, billionaire Oracle co-founder Larry Ellison, has called the deal "the most important deal in the industry" and the company has hired former Trump officials. 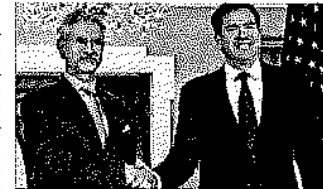
