Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and further to the Company's earlier disclosure dated January 09, 2026, we hereby inform you that the Company has filed a Writ Petition before the Hon'ble High Court of Gujarat at Ahmedabad, challenging the order dated January 09, 2026 passed by the Regional Director, North-Western Region, Ministry of Corporate Affairs, Ahmedabad.

The said order was passed by the Regional Director dismissing the appeal filed by the Company under Section 454(5) of the Companies Act, 2013 against the adjudication order dated August 08, 2024 passed by the Registrar of Companies, Ahmedabad, imposing penalties under Section 42(10) of the Companies Act, 2013 in relation to procedural non-compliance concerning the receipt and utilisation of share application money in connection with a preferential allotment made in January 2016.

The Company has filed the aforesaid Writ Petition challenging the Regional Director's order on the grounds set out therein.

The Company does not expect any significant impact on its financial, operational or other activities, except to the extent of the penalty exposure, subject to the outcome of the proceedings.

Pursuant to Regulation 30 read with Schedule III of SEBI (LODR) Regulations, 2015, and SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/1/3762/2026 dated 30th January, 2026, the details are provided in the enclosed **Annexure-I**.
