Pursuant to Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of the SEBI (LODR) (as amended), the Company is providing facility of remote e-voting to its Members before the AGM during the period from Sunday, September 10, 2023 to Wednesday, September 13, 2023 and also providing facility of e-voting during the AGM for those Shareholders, who have not cast their Vote before the AGM in respect of the business to be transacted at the said AGM. लक्सर। लक्सर तहसील क्षेत्र के खानपुर ब्लॉक के गांव मिर्जापुर मोहना वाला में ग्राम विकास अधिकारी से जहां जनता में नाराजगी है वही ग्राम प्रधान भी खुश नहीं है जब इस बात हमने जानना चाहा तो श्रीमती बबली प्रधान पति बबलू ने बताया कि विकास कार्य के बारे में जो भी चर्चा की जाती है और कार्य के लिए कहा जाता है तो वह नौ दो ग्यारह हो जाता है और कार्य को नहीं कर पाते खाली वक्त ही पास किया जा रहा है वही ग्रामीणों का कहना है कि ग्राम पंचायत विकास अधिकारी गांव में आपदा को लेकर भी चिंतित नहीं है कई बार कहने के बाद भी गांव में नहीं आते जिससे गांव में एवं प्रधान भी खामसे नाराज हैं बताया गया है कि ग्राम पंचायत विकास अधिकारी के खिलाफ गांव में कड़ी नाराजगी है और ग्रामीणों ने कहा कि हमें ऐसे ग्राम पंचायत विकास अधिकारी की जरूरत नहीं है ऐसे ग्राम पंचायत विकास अधिकारी को हमारी न्याय पंचायत से हटकर दूसरे ग्राम पंचायतों में लगा दिया जाए वही दूसरे ग्राम चंडपुरी बांगर के ग्राम प्रधान ने भी सख्त आरोप लगाया कहा कि अगर हम फोन करते हैं तो वादा तो कर लेते हैं मगर ब्लॉक में नहीं आते और अपने मोबाइल का स्विच ऑफ कर लेते हैं जिससे ग्राम पंचायत के ग्रामीण एवं ग्राम प्रधान भी उनके इस कार्य से तंग आ चुके हैं और ग्रामीणों का यह भी कहना है कि अगर उससे बात भी की जाती है कि गांव में विकास कार्य को बढ़ाया जाए तो वह नाराज से होते हैं और इसी बात को लेकर एक मामला भी सामने आया है जहां ग्राम



प्रधान के कहने सुनने पर ग्राम पंचायत विकास अधिकारी की ओर से ग्राम प्रधान के खिलाफ तहरीर दे दी जाती है और ग्राम प्रधान पर मुकदमा तक दर्ज करा दिया जाता है जिससे ग्राम प्रधान भी खामसे नाराज है जब हमने इस बाबा जानना चाहा तो मिर्जापुर मोहना वाला के ग्राम प्रधान पति बबलू की ओर से भी यही शिकायत नजर आई उनका भी कहना है कि गांव में विकास तक नहीं करा पा रहे हैं और अगर विकास के बारे में कहा जाता है तो उनके शब्द ग्राम प्रधानों के प्रति अच्छे नहीं हैं जिसको लेकर गांव के लोग भी खामसे नाराज हैं तो वही ग्राम प्रधान की ओर से भी कड़ी नाराजगी जताई गई है ग्राम प्रधान पति बबलू ने बताया कि अगर थोड़ी सी भी विकास के बारे में उसे कहा जाता है तो विकास कार्य के लिए तैयार नहीं हैं और गांव में महीना उससे बात भी की जाती है कि गांव में विकास कार्य को बढ़ाया जाए तो वह नाराज से होते हैं और इसी बात को लेकर एक हटा दिया जाए भी हमारे गांव में विकास कार्य हो सकेगा इस मौके पर रतीराम मांगा अनिल कुमार जौनी आशीष आदि ग्रामीणों ने कहा कि आपदा को लेकर भी ग्रामीण अधिकारियों से खामसे नाराज हैं और ग्राम विकास पंचायत अधिकारी की ओर से गांव में कोई तक्जो नहीं दी जा रही है और हल्का लेखपाल भी गांव में कभी-कभी आते हैं उससे पता चलता है कि जब वहां के लेखपालों का यह हाल है तो वहां के वीडियो के बारे में जानना चाहा तो ग्रामीणों एवं ग्राम प्रधानों की ओर से भी यही जवाब मिला है की वीडियो साहिबा यानी ब्लॉक प्रभारी महीने में सिर्फ एक या दो बार ही ब्लॉक में आती है और आज तो उनका दूरफर भी हो गया है अब देखना यह है कि खानपुर ब्लॉक में ब्लॉक प्रभारी कब आते हैं और कब विकास कार्य गांव में करते हैं यह भी अपने आप में एक बड़ा सवाल है। और सरकार एवं सरकार में बैठे अधिकारी इस और कितना ध्यान देते हैं या आने वाला वक्त बताएगा।
