1. Revenue From Operations

- The same store sales growth (SSSG) stood at +8% for the quarter (V-Mart at +7% and Unlimited at +10%).
- SSSG for the year stood at 11% and total Revenues grew by 18% YoY excluding LimeRoad digital marketplace.
- Income from LimeRoad digital marketplace of Rs. 8 Crore represents the commission income charged from sellers on the Net Merchandising Value (NMV) of Rs. 23 Crore.

The above revenue numbers are provisional and subject to review by the Statutory Auditors of the Company.

2. Store Opening & Closures

- The Company has opened 13 new stores and closed 4 stores during the quarter.
- The 13 New stores include Four (4) stores in Uttar Pradesh, Two (2) stores each in Bihar and Jharkhand and one (1) store each in West Bengal, Jammu and Kashmir, Assam, Arunachal Pradesh & Tamil Nadu.
