Pursuant to Regulation 30 read with Sub-para 20 of Para A of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Employees' State Insurance Corporation, Jammu ("the Authority"), vide prohibitory order dated August 07, 2025, instructed State Bank of India, Palm Court Building Branch ("the Bank") to debit an amount of ₹20,99,377/- from the account of Airplaza Retail Holdings Private Limited (a Subsidiary Company) towards recovery of pending dues.

In compliance with the above instructions, the Bank has debited the aforesaid amount from the Subsidiary's bank account on August 27, 2025 and remitted the same to the Authority. The Bank has simultaneously informed the Company on August 27, 2025 only of this action along with the copy of said Order via email.
