During the course of the inspection, the Officer collected samples of various food products stored at the premises. Upon analysis, it was found that one of the sampled products "Sooji (packed)" was not in the confirmation of the relevant provision of the Laws.</p> <p>Subsequently, the Food Safety Officer filed a complaint before the Additional District Magistrate, Haridwar, alleging violation of the provisions of the Food Safety and Standards Act, 2006. Pursuant thereto, a penalty of Rs. 50,000/- (Rupees Fifty Thousand Only) has been imposed upon the Subsidiary and Rs. 50,000/- (Rupees Fifty Thousand Only) has been imposed upon the Company.</p>
