### **3. Performance Highlights**

- Total revenue grew by **22.17%**, reaching **₹12.29 Cr** compared to **₹10.06 Cr** in the same quarter last year. The company's impressive increase in operational cities and billed locations underlines its aggressive market penetration strategy and ability to scale operations efficiently. Despite significant expansion, the company maintained healthy revenue growth, positioning itself for stronger profitability in the coming quarters
- Our revenues have grown by **14.91%** on a YOY basis owing to increase in clients from 9 to 15 and also increase in client locations from 18 to 31.
- In June 2025, the company reported ₹3.93 Cr. in revenue, reflecting a strong **14.91% YoY growth**, though slightly lower than May 2025's ₹4.26 Cr., registering a 7.75% MoM decline. The YoY growth highlights ongoing business expansion, while the monthly dip may reflect billing cycles, project timing, or seasonality."
