The number of clients billed increased from **12 in July 2024** to **16 in July 2025**, representing a **33.33% year-over-year (YOY) growth**. This upward trend continues month-over-month (MOM), with a **6.67% increase from 15 clients in June 2025** to 16 in July 2025, reflecting steady client acquisition momentum.

- **Geographic and Location Growth:**

Locations billed have expanded significantly, growing from **21 in July 2024** to **35 in July 2025**, an impressive **66.67% YOY increase**. The MOM growth also remains strong, with a **12.90% increase from 31 locations in June 2025** to 35 in July 2025. Additionally, the number of cities where the company operates more than doubled, rising from **5 to 11**, signalling aggressive geographical expansion and deeper market penetration.

- **Revenue Growth:**

Total revenue increased from ₹3.94 Cr in July 2024 to ₹4.57 Cr in July 2025, marking a **healthy 15.99% YOY growth**. The MOM revenue spike is even more pronounced, with a **16.28% increase from ₹3.93 Cr in June 2025 to ₹4.57 Cr in July 2025**. This suggests that not only is the customer base growing, but revenue per client/location is improving as well.
