Notes to the Statement of financial results:

- 1 The above financial results have been reviewed by the Audit committee and approved by the board of directors in their respective meetings held on August 7, 2026. These results have been subject to the limited review carried out by the statutory auditors.
- 2 The above financials have been prepared in accordance with the recognition and measurement principles provided by the Accounting Standards (AS) prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and the other accounting principles generally accepted in India, the provisions of the Companies Act, 2013 (the "Act"), as applicable and guidelines issued by the Securities and Exchange Board of India (SEBI) under SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended.
- 3 The Earnings per share (EPS) have been computed in accordance with the Accounting standards on Earnings per share (AS 20) which required effect of bonus to be given till the earliest period reported. EPS for the Quarter ended June 30, 2025, March 31, 2026 and June 30, 2026 are not annualised.
- 4 The company operates in a single reportable segment viz Employee Transportation services and hence there is no reportable segment as per requirements of Accounting Standard 17 on 'Operating Segments'.
- 5 The company does not have any Subsidiary, Associate or Joint Venture company(ies) as on June 30, 2026 and consequently, the company is not required to prepare consolidated financial results as per applicable laws and regulations.
- 6 The figures of the quarter ended March 31, 2026 are the balancing figures between the audited figures in respect of the full financial year and the unaudited published year-to-date figures up to the third quarter of the financial year ended March 31, 2026. The management has exercised necessary due diligence to ensure that the said comparative results provide a true and fair view of its affairs.
- 7 The comparative results for quarter ended March 31, 2026 have been audited and for the quarter ended June 30, 2025 have been reviewed by the auditor of the company. The management has exercised necessary due diligence to ensure that the said comparative results provide a true and fair view of its affairs.

Independent Auditors' Review Report on the Unaudited Financial Results of the Company for the quarter ended June 30, 2026 pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended

To the Board of Directors of Voler Car Limited (formerly known as 'Voler Car Private Limited')

1. We have reviewed the accompanying Statement of Unaudited Financial Results of **Voler Car Limited** (formerly known as 'Voler Car Private Limited') (the "Company"), for the quarter ended June 30, 2026 (the "Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the Listing Regulations).
2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in the Accounting Standard 25 'Interim Financial Reporting' (AS 25), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations.
