Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in continuation to our earlier intimation dated April 23, 2025, wherein we had informed the stock exchange that Vishnu Prakash R Punglia Limited (“the Company”) had received a Show Cause Notice dated March 28, 2025, bearing reference no. DGGI/INV/GST/1254/2023-GrA/17912, having F.NO. DGGI/INV/GST/1354/2023-Gr-A from the Delhi Zonal Unit of the Directorate General of GST Intelligence (DGGI), under the provisions of Section 74 & 122 of Central Goods and Services Tax Act, 2017 (CGST) read with the similar sections of Rajasthan Goods and Services Tax (RGST) Act, 2017, Chhattisgarh GST Act, 2017 & Section 20 of IGST Act, 2017.

We are pleased to inform that the proceedings initiated against Vishnu Prakash R Punglia Limited (the Company) and its Directors, pursuant to the Show Cause Notice dated 28.03.2025 issued by the Directorate General of GST Intelligence (DGGI), have been dropped in entirety.

The Show Cause Notice had alleged ineligible availment and passing of Input Tax Credit (ITC) amounting to INR 2,00,59,113/-, along with a proposed penalty of INR 23,12,99,448/-, total amounting to Rs. 25,13,58,561/-, on the Company and its Directors. The adjudicating authority, after detailed examination, concluded that the Company was found to have complied with all applicable provisions under Section 16 of the CGST Act, 2017, supported by valid documentation including tax invoices, work orders, and banking records. Accordingly, the entire demand including tax, interest, and penalties has been dropped, and the amounts now stand at nil.

Therefore, the proposed penalties against the Directors of the Company and other parties involved have been dropped, as no contravention or specific wrongdoing was found. Accordingly, there are no financial or legal implications on the Company or its Directors in connection with the said proceedings.
