This is in continuation to the Corporate Announcement submitted by our Company dated **April 23, 2025** under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for Notice Under Sub Section (1) of Section 148A of the Income Tax Act, 1961 received from Assistant Commissioner of Income Tax alleging income has escaped assessment for the A.Y 2019-20, we would like to submit that –

We were in the process of thoroughly evaluating the notice issued by the Assistant Commissioner of Income Tax. During this period, we were actively consulting with our advisors to assess the implications and determine an appropriate course of action. Upon completion of this internal assessment and once the necessary details, including a copy of the notice, were made available to the concerned officer, the information was promptly disclosed to the stock exchange. This sequence of events resulted in the delay in disclosure. It is important to note that internal communication was impacted by holidays and extended weekends during the said period, contributing to the delay. We would like to emphasize that the delay was entirely unintentional and occurred solely due to the time required for a comprehensive evaluation and ensuring accurate and complete disclosure in compliance with regulatory norms.
