This is in furtherance of the Corporate Announcement submitted by our Company dated **April 23, 2025** under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for Show Cause Notice dated 28.03.2025 bearing no. DGGI/INV/GST/1254/2023- GrA/17912 received from DZU Delhi, GST department on 21.04.2025 through DRC-01 under the provisions of Section 74 & 122 of Central Goods and Services Tax Act, 2017 (CGST) read with the similar sections of Rajasthan Goods and Services Tax (RGST) Act, 2017, Chhattisgarh GST Act, 2017 & Section 20 of IGST Act, 2017.

*Vide* Email dated April 24, 2025, your good office has sought from us the reason for delay in the aforementioned Corporate Announcement.

In this respect, we wish to clarify that the aforesaid Show Cause Notice was brought to the notice of the concerned Compliance Officer on 21.04.2025 through DRC-01. Thereafter, necessary clarifications were sought from the Accounts Department of the Company who had been in correspondence with the concerned GST Department, prior to the issuance of the Show Cause Notice i.e. during the investigation. Once the Accounts Department had comprehensively evaluated the contents of the Show Cause Notice and explained the same to the Compliance Officer, the Company promptly made the Corporate Announcement.

We would like to emphasize that the delay was entirely unintentional and was only caused on account of internal evaluation which would enable the Company to make an accurate and complete disclosure in compliance with regulatory norms.
