This is in reference to the announcement submitted by the Company on May 22, 2025 regarding revised Outcome of the Board Meeting held on Wednesday, May 14, 2025 wherein it was stated that the update on dividend was inadvertently

In the above case, the Exchange has observed that the aforesaid disclosure related to the Outcome of the Board Meeting for Dividend was not submitted within the prescribed timelines of within 30 minutes/ 3 hours of conclusion of the Board Meeting as per aforementioned provisions.
