Respected Sir,

I, **Mahendrakumar P Parmar, Advocate**, appointed by the Hon'ble National Company Law Tribunal, Ahmedabad Bench-I, Ahmedabad vide Order dated Order dated 17th October 2025 (date of pronouncement), passed in CA (CAA) No. 53 (AHM) of 2025 read with Order dated 24th November, 2025 (date of pronouncement) passed in CA No. 46 (AHM) of 2025 in CA (CAA) No. 53 (AHM) of 2025, to act as the Scrutinizer, for the meeting of Equity Shareholders of Share India Securities Ltd (hereinafter referred to as "the Transferee Company/the Company") held on Friday, 13th March, 2026, at 12:00 Noon through video conferencing, to consider and, if thought fit, approve, the Scheme of Amalgamation of Silverleaf Capital Services Pvt Ltd with Share India Securities Ltd (the Scheme of Amalgamation/the Scheme) and other connected matter, if any, submit my report as under:

1. That as directed by this Hon'ble Tribunal, the meeting of the Equity Shareholders of Share India Securities Ltd was duly convened and held on Friday, 13th March, 2026, at 12:00 Noon through video conferencing. The Chairperson-Mr Atul Lakhanpal, Senior Advocate, chaired the meeting; and the undersigned being the Scrutinizer of the meeting, attended the meeting through video conferencing. Legal Counsel of the Applicant Company-Mr Kartikeya Goel, Advocate and the senior management of the Applicant Company were also present in the meeting through video conferencing.
2. That Central Depository Services Limited (CDSL) was appointed to provide remote e-voting facility before the meeting and to provide e-voting platform during the meeting, in a secured manner and to provide platform for convening the meeting through Video Conferencing as well as to handle and supervise the entire process of holding the meeting through Video Conferencing, e-voting and processing of data relating to the meeting and voting, etc.




3. Voting upon the Scheme of Amalgamation was conducted through e-voting system in the meeting of Equity Shareholders of Share India Securities Ltd (the Transferee Company) held through video conferencing.
