This is with reference to the news item appearing in "<https://www.thehindu.com/>" dated 19th February 2026 captioned "Andhra secures Waaree Energies' battery giga-factory with ₹8,175 crore investment" and your email dated 19th February 2026.

We would like to inform you that the Board of Directors of the Company, at its meeting held on October 01, 2025, had approved the increase in the manufacturing capacity of Lithium-Ion Advanced Chemistry Storage Cells and Battery Energy Storage Systems (BESS) from 3.5 GWh to 20 GWh, along with an additional capital expenditure of approximately ₹8,000 crores in its wholly owned subsidiary, Waaree Energy Storage Solutions Private Limited.

The same was duly intimated to the stock exchanges on October 01, 2025.

Pursuant to the above, the Company is in discussions with the Government of Andhra Pradesh and certain other state governments for setting up the proposed greenfield manufacturing facility.

The Company shall keep the stock exchanges duly informed of any material developments in this matter, in accordance with applicable regulations.

The movement in the share price is market driven and there is no Unpublished Price Sensitive Information which is pending to be disclosed to the stock exchanges.
