Sub: Change in Directors

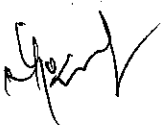

- b. Mr. Philippe Colpron (DIN:0008344534) was appointed as a non-executive, non-independent Director with effect from 29th January 2019 in terms of Section 161 of the Companies Act, 2013. His brief profile is given below:

Mr. Philippe Colpron, (40), currently the Vice President & Global Business Leader for Fleet Management Solutions of the WABCO Group, is responsible for growing the organization's holistic range of solutions for the commercial vehicle fleets ecosystem. He started his career in 2007 as Strategic Sourcing Director for the Group. In 2010 he became the Aftermarket Marketing & Business Development Leader. In 2012, he was promoted to the Business Enterprise Lead of WABCO Aftermarket and then promoted as Vice President and Aftermarket Business Unit Leader in 2014.
