Sloganeering row: Cops say mob violated prohibitory orders

It was alleged that Tauqueer Raza and another member of the organisation, Nadeem Khan, incited members of the Muslim community to gather at Islamia Ground in Bareilly to protest against authorities on Sept 26. The crowd assembled despite prohibitory orders in force and raised the said slogan and shouted anti-govt chants. When police teams tried to stop the crowd marching towards the collectorate, the protesters allegedly snatched their batons and tore uniforms. The crowd then allegedly threw stones and petrol bombs, fired, injuring police personnel.

"The slogans made by the crowd itself show that the persons involved in the protest march do not have any respect for the Indian legal system," Shrivastava said.

The court stated that raising or chanting slogans (devotional calls or proclamations) by any person or a crowd is not an offence unless they are maliciously used to intimidate people belonging to other religions. Though the slogan "gustakh-e-nabi..." does not have any trace in the Quran or any other Islamic religious text, even then the slogan is being used widely... without knowing its correct meaning and effect.

While passing the order, HC also mentioned the law of blasphemy enacted in Pakistan after partition. The court mentioned: "In 2011, a Christian woman, Asia Bibi, was convicted under the blasphemy law in Pakistan. The governor of Punjab, Salman Taseer supported the woman and this created a huge unrest. The crowd assembled on roads for protests under the leadership of Mulla Khadim Hussain Rizvi, who for the first time used the slogan."

Rihan's advocate argued in court that police falsely implicated his client and that he was arrested from his house, not from the "clash spot". In response, govt counsel Nitish Kumar Shrivastava said, "The act of the applicant (Rihan) and other co-accused is not only promoting enmity between the religious communities but also against the State as well as against the unity and integrity of India."

Corporate profit not sole pvt property: SC

Elaborating on the role of the private sector in the issue of environment, the bench said the corporate definition of social responsibility must inherently include environmental responsibility. "Companies cannot assert to be socially responsible while ignoring equal claims of the environment and other beings of the ecosystem. The Constitution, under Article 51A(g), imposes a fundamental duty on every citizen to protect and improve the natural environment, including forests, lakes, rivers and wildlife, and to have compassion for living creatures. A corporation, as a legal person and a key organ of society, shares this fundamental duty. CSR funds are the tangible expression of this duty. Consequently, allocating funds for the protection of environment is not a voluntary act of charity but a fulfilment of a constitutional obligation," Justice Narasimha, who penned the judgment for the bench, said. SC said CSR provision codifies the principle that corporate profit is not solely the private property of shareholders, but is partly owed to the society that enables its generation.

The bench accepted the recommendation of a court-appointed panel for preservation of GIB despite opposition from power generators. It approved revised priority conservation areas of 14,013 sq km in Rajasthan and 740 sq km in Gujarat. It also approved panel recommendation on blanket ban on the installation of solar projects over 2MW capacity or the laying of overhead transmission lines. 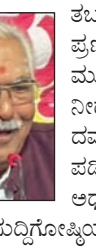
