**Sub.: Outcome of the Board Meeting held on 8<sup>th</sup> January, 2025 in accordance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations").**
