अमरावती, दि. १२: बुधवारी रात्री उशिरा वलगाव पोलिस स्टेशन परिसरात गोवंशावरून दोन गटांमध्ये जोरदार वाद झाला. वाद एवढा वाढला की काही लोकांनी वाहन अडवून, दगडफेक आणि तोडफोड केली. या घटनेनंतर दोन्ही समुदायातील लोक मोठ्या संख्येने ते एकमेकांशी भिडले. त्यावेळी परिसरात तणावपूर्ण परिस्थिती निर्माण झाली. माहिती मिळताच वलगाव पोलिस घटनास्थळी पोहोचले आणि गर्दीला पांगवण्यासाठी सौम्यदळ्याचा वापर करून परिस्थिती नियंत्रणात आणली. पोलिसांनी अतिरिक्त सुरक्षा तैनात केली आहे आणि परिसरात पेट्रोलिंग वाढवली आहे. आरोपीने चालकावर हल्ला शिवीगाळ केली आणि धमकी दिल्याचे वृत्त आहे. घटनेचे गंभीर लक्षात घेता, पोलिस उपायुक्त गणेश शिंदे आणि इतर वरिष्ठ अधिकारी देखील परिस्थितीचा आढावा घेण्यासाठी घटनास्थळी पोहोचले. पटावरून जनावरे परत आणत होते वृत्तानुसार, वलगाव पोलिस स्टेशन परिसरातील रहिवासी शेख उमर शेख नवाब (२२) हे दरवर्षीप्रमाणे बुधवारी तीन गुरांसह दूरपारला गेले होते. परत येत असताना, बडगावपाठवर हाऊसजवळ मोटारसायकलवरून आलेल्या काही गोरक्षक संबंधित पावत्या आणि

कारगदपत्राची मागणी करत समितीच्या कार्यकर्त्यांनी त्यांना थांबवले. गुरांशी संबंधित व्यक्तींनी वाद घातल्याचा आरोप आहे. वाद वाढल्याने हाणामारी झाली आणि प्रकरण हिंसक वळणावर पोहोचले. घटनेनंतर परिसरात तणाव वाढू लागला. पोलिसांनी घटनास्थळी जमलेल्या लोकांना घरी परतण्याचे आवाहन केले. वरिष्ठ अधिकाऱ्यांच्या मार्गदर्शनाखाली पोलिसांनी रात्री उशिरापर्यंत तपास सुरू होता. वलगाव पोलिसांनी गंभीर कलमांखाली गुन्हा दाखल केला आहे आणि पाच आरोपींना ताब्यात घेतले आहे. त्यांची कठोर चौकशी सुरू आहे. घटनेनंतर परिसरात अफवा पसरल्या, परंतु - जनतेला शांत

करण्यासाठी मोठा पोलिस बंदोबस्त - तैनात करण्यात आला. पोलिसांची गरस्त - वाढवल्यानंतर, परिसरात लवकरच शांतता पसरली. पोलिसप्रशासनाने नागरिकांना अफवांकडे दुर्लक्ष करून शांतता राखण्याचे आवाहन केले.
