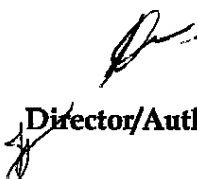
After aforesaid acquisition, the equity share holding of Welspun Promoter Group in Welspun Corp Limited stands at 74,711,409 (28.41%).

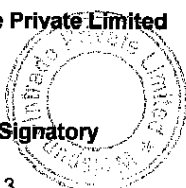
