Letter of Award of Purchase of power through competitive bidding process (followed by reverse e-auction) for Solarization of 11 KV Agricultural feeders emanating from selected 66 / 11 KV Sub-station in the supply area of PGVCL which involves Design, Survey, Supply, installation, testing, commissioning, Operation &maintenance for 25 years from Commercial Operation date (COD) of grid connected substation level Solar power plant, erection and maintenance of its associated 11 KV Line to evacuate power to the substation with Remote Monitoring System (RMS) as per the PM KUSUM Scheme Component-C-Feeder Level Solarization through RESCO model for Solar Power Plant (PG-FLS-TN9-156) having allocated Solar Capacity of 4.0 MW specification and other requirements as detailed in the order.
