Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has received a **Letter of Intent (LOI)** from one of our client companies for the execution of transmission line works under the **NTPC REL: 300 MW Project at Bhuj, Gujarat**, as outlined below:

1. A work order valued at approximately **₹35,40,00,000/-** (Rupees Thirty-Five Crore Forty Lakh Only), exclusive of GST, for **Single Stringing in Double Circuit Towers**.
2. A work order valued at approximately **₹3,85,00,000/-** (Rupees Three Crore Eighty-Five Lakh Only), exclusive of GST, for **Single Stringing in Multi Circuit Tower**.
