Members who attended the Meeting were given an opportunity to ask questions and seek Clarification. The Chairman appropriately responded to the questions raised by them.

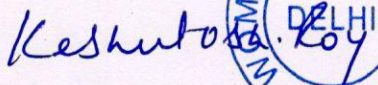
