Trump, Jordan's King set for tense meeting

Donald Trump meets Jordan's King Abdullah on Tuesday for what is likely to be a tense encounter following the US president's Gaza redevelopment idea and threat to cut aid to the US-allied Arab country if it refuses to resettle Palestinians.



Trump's proposed 'Riviera of the Middle East' has introduced new complexity into a sensitive regional dynamic, threatening the fragile ceasefire

Trump's proposal to transform the war-ravaged territory into the "Riviera of the Middle East" after displacing residents has drawn a negative response from the Arab world. The concept has introduced new complexity into a sensitive regional dynamic, including a fragile ceasefire between Israel and the Palestinian militant group Hamas.

King Abdullah has said he rejected any moves to annex land and displace Palestinians. On Tuesday, he is expected to tell Trump such a move could spur radicalism, spread chaos in the region, jeopardize peace

take refugees," Trump told reporters at the White House on Monday about King Abdullah. Asked if he would withhold aid from Jordan and Egypt if they declined to do so, Trump said, "Yeah, maybe, sure, why not... if they don't agree I would conceivably withhold aid."

Sandwiched between Saudi Arabia, Syria, Israel and the occupied West Bank, Jordan is already home to more than two million Palestinian refugees in its population of 11 million, their status and number long providing a source of anxiety for the country's leadership. Amman has come to depend on Washington as its largest source of economic and military assistance for decades, which now stands at more than \$1 billion a year. Jordan signed a peace treaty with Israel in 1994 but has strained relations with its neighbour. Israeli Prime Minister Benjamin Netanyahu has said Trump's proposal is worthy of exploration.

'Ukraine may be Russian someday'

US President Donald Trump has floated the idea that Ukraine "may be Russian someday", as his Vice-President JD Vance gears up to meet Ukrainian President Volodymyr Zelenskyy later this week on the sidelines of the Munich security conference. Pushing for an end to the nearly three-year war with Russia, Trump discussed the conflict in an interview with broadcaster Fox News that was aired on Monday.

"They may make a deal, they may not make a deal. They may be Russian someday, or they may not be Russian someday," he said. Trump also emphasised reaping a return on investment with US aid to Ukraine. "We are going to have all this money in there, and I say I want it back. And I told them that I want the equivalent, like \$500bn worth of rare earth," Trump said. "And they have essentially agreed to do that, so at least we don't feel

stupid." Trump also confirmed on Monday that he will soon dispatch to Ukraine his special envoy Keith Kellogg, who is tasked with drawing up a proposal to halt the fighting. Trump is pressing for a swift end to the conflict, while Zelenskyy is calling for tough security guarantees from Washington as part of any deal with Russia.

Kyiv fears that any settlement that does not include hard military commitments - such as Nato membership or the deployment of peace-keeping troops - will just allow the Kremlin time to regroup and rearm for a fresh attack. Zelenskyy called on Monday for "real peace and effective security guarantees" for Ukraine. "Security of people, security of our state, security of economic relations and, of course, our resource sustainability: not only for Ukraine, but for the entire free world," he said. "All of this is being decided now," Zelenskyy added in a video address published on social media.

Bar on food donations for World Food Programme lifted

NEW YORK/WASHINGTON: The United States has lifted a pause on food donations, the UN World Food Programme said, ending a suspension that an aid watchdog on Monday warned had left 500,000 metric tons of food currently at sea or ready to be shipped in a limbo. "We can confirm that the recent pause concerning in-kind food assistance to WFP - purchased from US farmers with Title II funds - has been rescinded," WFP said

in an X post. "This allows for the resumption of food purchases and deliveries under existing USAID agreements." Washington had stopped purchases of commodities produced by US farmers for donation - despite a waiver for emergency food assistance - after President Donald Trump pulled all foreign aid for 90 days so contributions could be reviewed to see if they aligned with his "America First" foreign policy.

Imran seeks fair trial in open court

Pakistan's jailed former Prime Minister Imran Khan has filed a petition before the Islamabad High Court requesting a hearing of his cases in the open court, saying multiple "false" cases have been registered against him, and his trial was being conducted in the "controlled" environment of Adiala Jail, Dawn reported. In the petition, Imran Khan said his trial was being conducted in the "controlled" environment of Adiala Jail in violation of law and the Constitution. It also said that his lawyers were being harassed.

The petition said the Pakistan Tehreek-e-Insaf (PTI) founder, Imran Khan, since his arrest in 2023 has never been presented before an open court and his trials have been conducted in makeshift courts in the prison. It was pointed out that the jail administration did not permit international media to cover the trial proceedings and only a handful of reporters were permitted to be present during the proceedings.

It is said that media could not mention former Pakistan PM's name and used the term 'PTI founder' for him. The petition urged the court to issue an order for conducting Imran Khan's open trial to ensure fair trial as mentioned in the constitution.

Houthis detain 8 staffers, UN suspends aid

The United Nations said Monday it suspended its humanitarian operations in the stronghold of Yemen's Houthi rebels after they detained eight more UN staffers, affecting the global response to one of the world's worst humanitarian disasters. In a statement, the UN said the "extraordinary" decision to pause all operations and programmes in northern Saada province was due to the lack of necessary security conditions and guarantees.

A spokesman for the Houthis didn't immediately respond to messages seeking comment. The rebels in recent months have detained dozens of UN staffers, as well as people associated with aid groups, civil society and the once-open US Embassy in Sanaa, Yemen's capital. None of the UN staffers has been released. The UN statement said the pause in operations is meant to give the Houthis and the world body time to "arrange the release of arbitrarily detained UN personnel and ensure that the necessary conditions are in place to deliver critical humanitarian support" in rebel-held areas.
