Teenager stabbed to death

INDORE: A 16-year-old boy was stabbed to death in Scheme Number 78 on Wednesday night. The teenager was identified as Hitesh Jagtap, son of Kamlesh Jagtap. He worked at a plywood shop. Ayush Jain, who claimed to be Hitesh's guardian, told the police that a few minutes back Hitesh had told him that he would be back in 5 minutes and then both would have dinner together. Around half-an-hour later, Hitesh's friend informed Ayush on phone that he had been stabbed. He was rushed to a city hospital where he died during course of treatment. Police suspect that a sharp-edged tile was used to stab Hitesh.

Two arrested with stolen grocery items

Two persons were arrested in connection with Pardeshipura grocery shop theft case. Stolen goods worth thousands of rupees were recovered from them. Pardeshipura police station in charge Ashok Patidar said that shop-owner Kachrumal Agrawal had lodged a complaint that thieves entered into his shop from bathroom and decamped with Rs 10,000 cash and bags containing cashew, almond along with seven boxes of edible oil on August 20. On Wednesday, ASI Alha Singh was tipped off about two persons trying to sell grocery items near Sugni Devi College ground. The police team reached the place and detained them. The duo was identified as Rahul Reswal and Deepak Akhand of Pardeshipura.

Two held for land fraud

The police on Wednesday arrested two men from Mumbai for land fraud with a resident of Bhanwarakuwan. Police said that accused Raj Paryani and Mukesh Paryani were arrested on the complaint of Mahesh Rathi. The victim bought a plot from the accused in 2015. He had paid them Rs 13 lakh for the plot but the accused were yet to hand over the possession of the land.

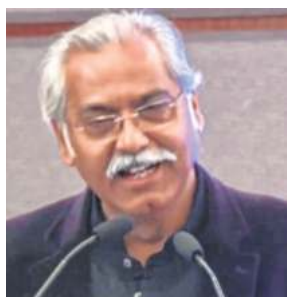
