Pursuant to Regulation 30 of SEBI (LODR) Regulations, 2015 read with Sub-Para 20 of Para A of Part A of Schedule III we hereby inform you that the Company has received Letter No. **NSE/LIST-SOP/FINES/0717** dated **30th June, 2026** from the National Stock Exchange of India Limited regarding levy of fine under the Standard Operating Procedure for alleged non-compliance/delayed compliance with the provisions of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Company is in process applying to NSE for waiver of fine, in accordance with the Policy on Processing of Waiver Applications, as the non-compliance was inadvertent and unintentional in nature.

Further, the details required under Regulation 30 read with clause 20 of Para A Part A of Schedule III of Listing Regulations, and SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/CIR/P/2024/185 dated December 31, 2024 is enclosed herewith as an **Annexure A**.

The Company respectfully submits that the observations contained in the aforesaid communication pertain to inadvertent procedural lapses during the electronic filing process. The audited financial results had been duly approved by the Board of Directors and disseminated to the Exchange. The Company has since completed the requisite compliances, undertaken necessary corrective actions and submitted an application to the Exchange seeking waiver of the fine in accordance with the applicable policy.
