I hereby appraise that pursuant to Regulation 15(2) of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time (hereinafter referred to as the said "SEBI (LODR) Regulations, 2015"), the compliance with the corporate governance provisions as specified under Regulations 17 to 27, clauses (b) to (i) of Regulation 46(2), and Paras C, D and E of Schedule V of the SEBI (LODR) Regulations, 2015 (hereinafter referred as LODR Regulations, 2015) shall not apply, when Listed Company is attaining any of below stated criteria as follows.

- a) The listed entity having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty-five crore, as on the last day of previous financial year.
- b) The listed entity which has listed its specified securities on the SME Exchange.

Considering the relaxation provided to SME listed companies the provision related to the filing of Corporate Governance Report under Regulation 27 of SEBI (LODR) 2015 are not applicable to Wise Travel India Limited for the Quarter ended 30th June, 2026.

Therefore, the company is not required to comply with the provisions of Corporate Governance as mentioned herein except Regulation 23 (LODR) as the company has Related Party Transactions during the year under review.
