Approval for increase in overall borrowing limits of the company as per section 180(1)(c) of the Companies act, 2013 which **shall not exceed at any point in time a sum equivalent to Rs. 250 crores/- (Rupees Two hundred fifty crores Only)** in addition to the aggregate of the paid-up share capital, free reserves and securities premium account of the Company, as applicable. and under 180(1)(a) of the Companies act, 2013 for providing authority for sale, lease or otherwise disposal of the whole or substantially the whole of the undertaking(s) of the Company, which **shall not exceed at any point in time a sum equivalent to Rs. 25 crores/- (Rupees Twenty-Five crores Only)**.

The aforesaid proposals shall be subject to the approval of the members of the Company at the ensuing Annual General Meeting.

2. 17th Annual General Meeting (AGM) of the Company scheduled to be held on **Friday, 25th September, 2026 at 03:00 P.M. (IST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM")**.
3. Approval of Draft Annual Report Including Board's Report and requisite Annexures for the Financial Year ended 31st March, 2026, subject to such modifications, amendments or changes as may be necessary or appropriate in accordance with applicable laws and regulatory requirements.
4. Register of Members and Share Transfer Books shall remain closed from Saturday, September 19, 2026 to Friday, September 25, 2026 (both days inclusive) in connection with the ensuing Annual General Meeting.
5. Ms. Sheetal, Practicing Company Secretary, Delhi (Membership No.10780, CP No. 15204) has been appointed as the Scrutinizer for e-voting and voting at the AGM at the ensuing 17th Annual General Meeting of the Company for the Financial Year 2025-26.
