WILL SIGN ECONOMIC, SECURITY, DIPLOMATIC PACTS: NETANYAHU Pacts on table, PM in Israel to strengthen bilateral ties

New Delhi, February 25

AS INDIA AND ISRAEL look to elevate their strategic partnership, Prime Minister Narendra Modi arrived in Tel Aviv Wednesday on a two-day visit. He is meeting Israeli counterpart Benjamin Netanyahu and the two sides are expected to sign a slew of pacts in the economic, security and diplomatic spheres to deepen bilateral ties.

Modi's visit to Israel is taking place amid turmoil in the region, talk of a potential US strike on Iran should negotiations fail in Geneva and US President Donald Trump's Board of Peace Initiative to rebuild Gaza and deploy an international stabilisation force in the ravaged Strip. India has stayed away from the Board and attended its first meeting as an observer. Modi was received by Netanyahu and his wife Sara at the Ben Gurion international airport, and the two leaders held a private meeting there after. They will meet Thursday for official bilateral talks.

Modi, in a post on X, said

"Had an excellent meeting with Prime Minister Netanyahu. Expressed gratitude to him for the warm welcome earlier in the day. It is a delight to be back in Israel after 9 years. We discussed a wide range of subjects aimed at boosting bilateral ties. Sectors such as technology, water management, agriculture, talent partnership and more offer

immense scope for close collaboration. We also discussed key developments in the region."

"I am extremely honoured to be received by Prime Minister Netanyahu and Mrs Netanyahu at the airport. I look forward to engaging in bilateral discussions and fruitful outcomes that strengthen the India-Israel friendship," he said.

Welcoming him, Netanyahu said, "This is a bond of real friendship! My wife Sara and I welcomed today our good friend, Prime Minister of India Narendra Modi, who has arrived for another historic visit to Israel. Prime Minister Modi previously visited Israel in 2017, and I later paid a reciprocal visit to India that was truly exceptional."

Govt plans price support for chana

TO REPLENISH THE buffer and ensure remunerative prices to farmers, the agriculture ministry has approved procurement of 2.3 million tonne (MT) of chana (gram) in Maharashtra, Gujarat, Madhya Pradesh and Rajasthan under the price support scheme (PSS) for 2026-27 rabi marketing season.

The agriculture ministry has approved procurement of 0.76 MT of chana from Maharashtra, 0.58 MT from Madhya Pradesh, 0.55 MT from Rajasthan and 0.41 MT from Gujarat. Last month, under PSS, the ministry approved the purchase of 0.1 MT of chana. Sources said that with arrivals of newly harvested chana in Maharashtra, the market prices are currently ruling 15% to 20% below the minimum support price (MSP) of ₹5,875/quintal for the pulse for the current marketing season.

"The standing crop of chana is progressing well with the beginning of harvesting season. The government's procurement at MSP will support farmer realisation and help maintain price stability during peak arrivals," Harsha Rai, head of Mayur Global Corporation, a leading pulses trading firm, told FE.

Chana output declined to 11.11 MT in 2024-25 after a record harvest of 13.54 MT in the 2021-22 crop year (July-June), leading to prices ruling above MSP for the last couple of years. This led to a drop in buffer stock and the government stopped providing chana under Bharat dal.

The government allowed liberalised imports of yellow peas and bengal grams to meet shortfall in domestic output in the last few years.

Area under chana in the current rabi season has risen over 5.1% to 9.59 million hectares from a year ago. According to government estimates, chana output will be around 11.5 MT in the 2025-26 crop year.

Against a buffer norm of 1 MT, the government currently holds a chana stock of around 0.2 MT. Under the stocking norm, the government needs to hold 2 MT of varieties of pulses aimed at ensuring price stability.

Chana has accounted for nearly 50% of the country's pulses production in the last two seasons.

Procurement by agencies such as Nafed and NCCF is likely to commence from March 15. Procurement of pulses is facilitated through the eSamridhi (NAFED) and aSamyukti (NCCF) portals, with over 1.18 million and 1.6 million farmers registered with the agencies, respectively.

In addition, the ministry has approved MSP purchase of 0.6 MT of masoor (lentil) in Madhya Pradesh.

The government has approved the purchase of 1.3 MT of mustard in Rajasthan and 0.13 MT in Gujarat.

BMC presents ₹81K-cr budget; capex pegged at ₹48,164 cr

THE BRIHANMUMBAI MUNICIPAL Corporation (BMC) on Wednesday proposed a budget outlay of ₹80,952.56 crore for the financial year 2026-27, marking an 8.77% increase over the 2025-26 budget estimate of ₹74,427.41 crore.

BMC Commissioner Bhushan Gagrani tabled the budget in the country's richest civic body, with the capital expenditure pegged at ₹48,164.28 crore, reflecting a rise of about 11.59% over the revised estimate of

₹39,159.51 crore for 2025-26.

The capital outlay in 2025-26 was originally estimated at ₹43,162.23 crore, but was subsequently revised downward.

Revenue expenditure for 2026-27 is proposed at ₹32,698.44 crore, about 15.71% higher than the revised estimate of ₹28,257.91 crore for 2025-26. The revenue expenditure for the current fiscal was initially estimated at ₹31,204.53 crore but later reduced by ₹2,946.62 crore following expenditure rationalisation measures.

The estimated revenue

income for 2026-27 stands at ₹51,510.94 crore, 19.35% higher than the previous budget estimate of ₹43,159.40 crore. The 2025-26 revenue income estimate was later revised upward to ₹46,778.12 crore, an increase of 8.38%.

All available spectrum, across nine frequency bands, should be put to auction in the forthcoming bidding, the telecom regulator recommended.

While the reserve or base price is lower than 2022 auctions for most LSA (Licensed Shared Access) and band combinations, in a few cases, it is higher than the previous sale.

ISMA reduces sugar output estimates to 32.4 MT

THE SUGAR INDUSTRY on Wednesday revised downward its earlier projection of the sweetener's production in the 2025-26 season (October-September) to 32.4 million tonne (MT) from 34.35 MT citing lower productivity in Uttar Pradesh, Maharashtra and Karnataka.

Indian Sugar and Bio-energy Manufacturers Association (ISMA) while releasing the third advance estimates of sugar production stated that the sweetener's output is expected to rise by 10% to 32.4 MT in 2025-26 season against 29.6 MT in previous season.

"The sugarcane yield in Uttar Pradesh is lower than earlier projections. This is primarily attributable to the ongoing varietal replacement programme in the state, which has temporarily impacted productivity levels," ISMA stated after its executive committee meeting.

In the key sugarcane-growing regions of Maharashtra and Karnataka, the yields per

unit area are lower than initially expected, despite reasonable sugar recovery levels.

This shortfall in yield has been linked to the early onset of flowering in sugarcane, which began across many cane-growing regions from January onwards, rather than being confined to only traditional river belts, the associations of sugar mills stated.

"Early flowering — often triggered by abnormal weather patterns, including excess rainfall during key growth phases — accelerates cane maturity and reduces biomass accumulation, resulting in lighter, less productive stalks," ISMA stated.

It has projected that while 3.1 MT sugar will be diverted for ethanol, the net sugar production during the current season is projected at 29.2 MT. The carry forward stock of the sweetener as on October 1, 2026, is projected at 5.3 MT, which will be more than adequate to meet the demand.

The consumption of sugar is projected at 28.3 MT for the current sugar season. India is likely to export 0.7 MT of the sweet-

ener in the current season. Based on post-monsoon pan-India satellite imagery captured in October 2025, ISMA had earlier stated that said the total sugarcane acreage in 2025-26 season is estimated at around 5.73 mil-

lion hectare (Mha), compared to 5.71 Mha in 2024-25 season, indicating a marginal increase over last year.

The industry had earlier expressed the concern that a 'small' portion of total requirement for ethanol from sugar-based feedstock for the supply year (ESY) 2025-26 has been allocated by oil marketing companies.

It had stated that only 2,890 million litres of ethanol, just 28% of the total requirement, have been allocated from sugar-based feedstocks for the 2025-26 ESY, compared to 72% or 7,610 million litres from grain-based sources — 4,780 million litres from maize (45%), and 2,830 million litres from rice (22%).

Earlier, the sugar industry also demanded revision of minimum sales price (MSP) of sugar which has remained unchanged at Rs 31/kg since February 2019, while fair and remunerative prices (FRP) has increased by 29% to Rs 355/quintal, which had boosted cost of production to Rs 40.24/kg at present.

WILL SIGN ECONOMIC, SECURITY, DIPLOMATIC PACTS: NETANYAHU

Pacts on table, PM in Israel to strengthen bilateral ties

New Delhi, February 25

AS INDIA AND ISRAEL look to elevate their strategic partnership, Prime Minister Narendra Modi arrived in Tel Aviv Wednesday on a two-day visit. He is meeting Israeli counterpart Benjamin Netanyahu and the two sides are expected to sign a slew of pacts in the economic, security and diplomatic spheres to deepen bilateral ties.

Modi's visit to Israel is taking place amid turmoil in the region, talk of a potential US strike on Iran should negotiations fail in Geneva and US President Donald Trump's Board of Peace initiative to rebuild Gaza and deploy an international stabilisation force in the ravaged Strip. India has stayed away from the Board and attended its first meeting as an observer.

Modi was received by Netanyahu and his wife Sara at the Ben Gurion international airport, and the two leaders held a private meeting there after. They will meet Thursday for official bilateral talks.

Modi, in a post on X, said, "Had an excellent meeting with Prime Minister Netanyahu. Expressed gratitude to him for the warm welcome earlier in the day. It is a delight to be back in Israel after 9 years. We discussed a wide range of subjects aimed at boosting bilateral ties. Sectors such as technology, water management, agricul-



ture, talent partnership and more offer immense scope for close collaboration. We also discussed key developments in the region."

"I am extremely honoured to be received by Prime Minister Netanyahu and Mrs Netanyahu at the airport. I look forward to engaging in bilateral discussions and fruitful outcomes that strengthen the India-Israel friendship," he said.

Welcoming him, Netanyahu said, "This is a bond of real friendship! My wife Sara and I welcomed today our good friend, Prime Minister of India Narendra Modi, who has arrived for another historic visit to Israel. Prime Minister Modi previously visited Israel in 2017, and I later paid a reci-

procal visit to India that was truly exceptional."

"We share a close personal relationship, speak often, and I believe that the deep friendship between us powerfully reflects on the ties between our two countries," he said, adding they will attend a festive reception at the Knesset, visit an innovation event in Jerusalem, and host Prime Minister Modi for a joint dinner.

"Tomorrow we will visit Yad Vashem, and afterwards hold another meeting together with our teams, during which we will sign a series of agreements in the economic, security, and diplomatic spheres that will further advance cooperation between Israel and India," Netanyahu said.

July 2017, the India-Israel bilateral relationship was elevated to 'Strategic Partnership'. Now, the plan is to elevate this partnership. India and Israel share a robust strategic partnership with strong cooperation across science and technology, innovation, defence and security, trade and investment, agriculture, water and people-to-people contact.

Modi is skipping a visit to Palestinian Authority-governed Ramallah in the West Bank again, as he did during his visit to Israel in 2017. He went to Ramallah in February 2018 on a separate bilateral visit. At that time, New Delhi had framed it as a de-hyphenation of the Israel-Palestine issue, staying committed to a two-state solution.

ISMA cuts sugar output estimates to 32.4 MT

THE SUGAR INDUSTRY on Wednesday revised downward its earlier projection of the sweetener's production in the 2025-26 season (October-September) to 32.4 million tonne (MT) from 34.35 MT citing lower productivity in Uttar Pradesh, Maharashtra and Karnataka.

Indian Sugar and Bio-energy Manufacturers Association (ISMA) while releasing the third advance estimates of sugar production stated that the sweetener's output is expected to rise by 10% to 32.4 MT in 2025-26 season against 29.6 MT in previous season.

"The sugarcane yield in Uttar Pradesh is lower than earlier projections. This is primarily attributable to the ongoing varietal replacement programme in the state, which has temporarily impacted productivity levels," ISMA stated after its executive committee meeting.

In the key sugarcane-growing regions of Maharashtra and Karnataka, the yields per unit area are lower than initially expected, despite reasonable sugar recovery levels.

This shortfall in yield has been linked to the early onset of flowering in sugarcane, which began across many cane-growing regions from January onwards, rather than being confined to only traditional river belts, the associations of

sugar mills stated.

"Early flowering — often triggered by abnormal weather patterns, including excess rainfall during key growth phases — accelerates cane maturity and reduces biomass accumulating, resulting in lighter, less productive stalks," ISMA stated.

It has projected that while 3.1 MT sugar will be diverted for ethanol, the net sugar production during the current season is projected at 29.2 MT. The carry forward stock of the sweetener as on October 1, 2026, is projected at 5.3 MT, which will be more than adequate to meet the demand.

The consumption of sugar

is projected at 28.3 MT for the current sugar season. India is likely to export 0.7 MT of the sweetener in the current season.

Based on post-monsoon pan-India satellite imagery captured in October 2025, ISMA had earlier stated that said the total sugarcane acreage in 2025-26 season is estimated at around 5.73 million hectare (Mha), compared to 5.71 Mha in 2024-25 season, indicating a marginal increase over last year.

The industry had earlier expressed the concern that a 'small' portion of total requirement for ethanol from sugar-based feedstock for the supply year (ESY) 2025-26 has been allocated by oil marketing companies.

It had stated that only 2,890 million litres of ethanol, just 28% of the total requirement, have been allocated from sugar-based feedstocks for the 2025-26 ESY, compared to 72% or 7,610 million litres from grain-based sources — 4,780 million litres from maize (45%), and 2,830 million litres from rice (22%).

Earlier, the sugar industry also demanded revision of minimum sales price (MSP) of sugar which has remained unchanged at ₹31/kg since February 2019, while fair and remunerative prices (FRP) has increased by 29% to ₹355/quintal, which had boosted cost of production to ₹40.24/kg at present.

Govt plans price support for chana

TO REPLENISH THE buffer and ensure remunerative prices to farmers, the agriculture ministry has approved procurement of 2.3 million tonne (MT) of chana (gram) in Maharashtra, Gujarat, Madhya Pradesh and Rajasthan under the price support scheme (PSS) for 2026-27 rabi marketing season.

The agriculture ministry has approved procurement of 0.76 MT of chana from Maharashtra, 0.58 MT from Madhya Pradesh, 0.55 MT from Rajasthan and 0.41 MT from Gujarat. Last month, under PSS, the ministry approved the purchase of 0.1 MT of chana. Sources said that with arrivals of newly harvested chana in Maharashtra, the market prices are currently ruling 15% to 20% below the minimum support price (MSP) of ₹5,875/quintal for the pulse for the current marketing season.

"The standing crop of chana is progressing well with the beginning of harvesting season. The government's procurement at MSP will support farmer realisation and help maintain price stability during peak arrivals," Harsha Rai, head of Mayur Global Corporation, a leading pulses trading firm, told FE.

Chana output declined to 11.11 MT in 2024-25 after a record harvest of 13.54 MT in the 2021-22 crop year (July-June), leading to prices ruling above MSP for the last couple of years.

BMC presents ₹81K-cr budget; capex pegged at ₹48,164 cr

THE BRIHANMUMBAI MUNICIPAL Corporation (BMC) on Wednesday proposed a budget outlay of ₹80,952.56 crore for the financial year 2026-27, marking an 8.77% increase over the 2025-26 budget estimate of ₹74,427.41 crore.

BMC Commissioner Bhushan Gagrani tabled the budget in the country's richest civic body, with the capital expenditure pegged at ₹48,164.28 crore, reflecting a rise of about 11.59% over the revised estimate of ₹39,159.51 crore for 2025-26. The capital outlay in 2025-26 was originally estimated at ₹43,162.23 crore, but was



subsequently revised downward. Revenue expenditure for 2026-27 is proposed at ₹32,698.44 crore, about 15.71% higher than the revised estimate of

₹28,257.91 crore for 2025-26. The revenue expenditure for the current fiscal was initially estimated at ₹31,204.53 crore but later reduced by ₹2,946.62 crore following expenditure rationalisation measures.

The estimated revenue income for 2026-27 stands at ₹51,510.94 crore, 19.35% higher than the previous budget estimate of ₹43,159.40 crore. The 2025-26 revenue income estimate was later revised upward to ₹46,778.12 crore, an increase of 8.38%.

All available spectrum, across nine frequency bands, should be put to auction in the forthcoming bidding, the telecom regulator recommended.

While the reserve or base price is lower than 2022 auc-

tions for most LSA (Licensed Shared Access) and band combinations, in a few cases, it is higher than the previous sale. In its recommendation that spans the modalities for spectrum auctions, such as applicable reserve price, band plan, block size, and associated conditions for spectrum bids, Trai said the DoT should immediately reclaim spectrum held by providers undergoing insolvency and include those airwaves in the upcoming auction.

"The entire available spectrum in the 600 MHz, 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, 2300 MHz, 2500 MHz, 3300 MHz and 26 GHz frequency bands should be put to auction in the forthcoming auction," Trai said on Tuesday.

Scindia condemns BSNL director's 'VIP protocol' for Prayagraj visit

UNION COMMUNICATIONS MINISTER Jyotiraditya Scindia on Wednesday strongly condemned the VIP protocol prepared for the BSNL director's visit to Prayagraj, calling the arrangements improper, unacceptable and a violation of established rules. The minister confirmed that a show-cause notice has been issued to Vivek Banzal, director (consumer fixed

access) at BSNL, seeking an explanation within seven days, and said an appropriate action would follow.

"I have made it very clear that this is improper and a violation of established rules and traditions. It is unacceptable, it is shocking," Scindia said, indicating that the government has taken serious note of the incident.

The controversy erupted after an internal BSNL document detailing elaborate arrangements for Banzal's proposed two-day visit went viral. The plan reportedly involved deployment of nearly 50 officials to manage logistics and personal comfort, including arrangements for toiletries, bath kits and other personal items.

This triggered widespread criticism over alleged misuse of public resources and VIP culture within a state-run telecom company. The proposed visit, scheduled for February 25-26, was subsequently cancelled, and BSNL acknowledged that the arrangements were not in line with its professional standards.

Pacts on table, PM in Israel to strengthen bilateral ties

AS INDIA AND ISRAEL look to elevate their strategic partnership, Prime Minister Narendra Modi arrived in Tel Aviv Wednesday on a two-day visit. He is meeting Israeli counterpart Benjamin Netanyahu and the two sides are expected to sign a slew of pacts in the economic, security and diplomatic spheres to deepen bilateral ties.

Modi's visit to Israel is taking place amid turmoil in the region, talk of a potential US strike on Iran should negotiations fail in Geneva and US President Donald Trump's Board of Peace initiative to rebuild Gaza and deploy an international stabilisation force in the ravaged Strip. India has stayed away from the Board and attended its first meeting as an observer.

“Had an excellent meeting with Prime Minister Netanyahu. Expressed gratitude to him for the warm welcome earlier in the day. It is a delight to be back in Israel after 9 years. We discussed a wide range of subjects aimed at boosting bilateral ties. Sectors such as technology, water management, agriculture, talent partnership and more offer

immense scope for close collaboration. We also discussed key developments in the region.”

Welcoming him, Netanyahu said, “This is a bond of real friendship! My wife Sara and I welcomed today our good friend, Prime Minister of India Narendra Modi, who has arrived for another historic visit to Israel. ISMA reduces sugar output estimates to 32.4 MT

THE SUGAR INDUSTRY on Wednesday revised downward its earlier projection of the sweetener's production in the 2025-26 season (October-September) to 32.4 million tonne (MT) from 34.35 MT citing lower productivity in Uttar Pradesh, Maharashtra and Karnataka.

Indian Sugar and Bio-energy Manufacturers Association (ISMA) while releasing the third advance estimates of sugar production stated that the sweetener's output is expected to rise by 10% to 32.4 MT in 2025-26 season against 29.6 MT in previous season.

This shortfall in yield has been linked to the early onset of flowering in sugarcane, which began across many cane-growing regions from January onwards, rather than being confined to only traditional river belts, the associations of sugar mills stated.

“The sugarcane yield in Uttar Pradesh is lower than earlier projections. This is primarily attributable to the ongoing varietal replacement programme in the state, which has temporarily impacted productivity levels,” ISMA stated after its executive committee meeting.

“Early flowering — often triggered by abnormal weather patterns, including excess rainfall during key growth phases — accelerates cane maturity and reduces biomass accumulation, resulting in lighter, less productive stalks,” ISMA stated.

It had stated that only 2,890 million litres of ethanol, just 28% of the total requirement, have been allocated from sugar-based feedstocks for the 2025-26 ES, compared to 72% or 7,610 million litres from grain-based sources — 4,780 million litres from maize (45%), and 2,830 million litres from rice (22%).

It has projected that while 3.1 MT sugar will be diverted for ethanol, the net sugar production during the current season is projected at 29.2 MT. The carry forward stock of the sweetener as on October 1, 2026, is projected at 5.3 MT, which will be more than adequate to meet the demand.

Sources said that with arrivals of newly harvested chana in Maharashtra, the market prices are currently ruling 15% to 20% below the minimum support price (MSP) of ₹5,875/quintal for the pulse for the current marketing season.

The government's procurement at MSP will support farmer realisation and help maintain price stability during peak arrivals,” Harsha Rai, head of Mayur Global Corporation, a leading pulses trading firm, told FE.

Chana output declined to 11.11 MT in 2024-25 after a record harvest of 13.54 MT in the 2021-22 crop year (July-June), leading to prices ruling above MSP for the last couple of years. This led to a drop in buffer stock and the government stopped providing chana under Bharat dal.

The government allowed liberalised imports of yellow peas and bengal gram to meet shortfall in domestic output in the last few years.

Area under chana in the current rabi season has risen over 5.1% to 9.59 million hectares from a year ago. According to government estimates, chana output will be around 11.5 MT in the 2025-26 crop year.

Against a buffer norm of 1 MT, the government currently holds a chana stock of around 0.2 MT. Under the stocking norm, the government needs to hold 2 MT of varieties of pulses aimed at ensuring price stability.

Chana has accounted for nearly 50% of the country's pulses production in the last two seasons.

Procurement by agencies such as Nafed and NCCF is likely to commence from March 15. Procurement of pulses is facilitated through the eSamridhi (NAFED) and aSamyukti (NCCF) portals, with over 1.18 million and 1.6 million farmers registered with the agencies, respectively.

In addition, the ministry has approved MSP purchase of 0.6 MT of masoor (lentil) in Madhya Pradesh.

The government has approved the purchase of 1.3 MT of mustard in Rajasthan and 0.13 MT in Gujarat.

WILL SIGN ECONOMIC, SECURITY, DIPLOMATIC PACTS: NETANYAHU

Pacts on table, PM in Israel to strengthen bilateral ties

New Delhi, February 25

AS INDIA AND ISRAEL look to elevate their strategic partnership, Prime Minister Narendra Modi arrived in Tel Aviv Wednesday on a two-day visit. He is meeting Israeli counterpart Benjamin Netanyahu and the two sides are expected to sign a slew of pacts in the economic, security and diplomatic spheres to deepen bilateral ties.

Modi's visit to Israel is taking place amid turmoil in the region, talk of a potential US strike on Iran should negotiations fail in Geneva and US President Donald Trump's Board of Peace initiative to rebuild Gaza and deploy an international stabilisation force in the ravaged Strip. India has stayed away from the Board and attended its first meeting as an observer.

Modi was received by Netanyahu and his wife Sara at the Ben Gurion international airport, and the two leaders held a private meeting there after. They will meet Thursday for official bilateral talks.

Modi, in a post on X, said,

"Had an excellent meeting with Prime Minister Netanyahu. Expressed gratitude to him for the warm welcome earlier in the day. It is a delight to be back in Israel after 9 years. We discussed a wide range of subjects aimed at boosting bilateral ties. Sectors such as technology, water management, agriculture, talent partnership and more offer

immense scope for close collaboration. We also discussed key developments in the region."

"I am extremely honoured to be received by Prime Minister Netanyahu and Mrs Netanyahu at the airport. I look forward to engaging in bilateral discussions and fruitful outcomes that strengthen the India-Israel friendship," he said.

Welcoming him, Netanyahu said, "This is a bond of real friendship! My wife Sara and I welcomed today our good friend, Prime Minister of India Narendra Modi, who has arrived for another historic visit to Israel. Prime Minister Modi previously visited Israel in 2017, and I later paid a reciprocal visit to India that was truly exceptional."

ISMA reduces sugar output estimates to 32.4 MT

THE SUGAR INDUSTRY on Wednesday revised downward its earlier projection of the sweetener's production in the 2025-26 season (October-September) to 32.4 million tonne (MT) from 34.35 MT citing lower productivity in Uttar Pradesh, Maharashtra and Karnataka.

Indian Sugar and Bio-energy Manufacturers Association (ISMA) while releasing the third advance estimates of sugar production stated that the sweetener's output is expected to rise by 10% to 32.4 MT in 2025-26 season against 29.6 MT in previous season.

"The sugarcane yield in Uttar Pradesh is lower than earlier projections. This is primarily attributable to the ongoing varietal replacement programme in the state, which has temporarily impacted productivity levels," ISMA stated after its executive committee meeting.

In the key sugarcane-growing regions of Maharashtra and Karnataka, the yields per

unit area are lower than initially expected, despite reasonable sugar recovery levels.

This shortfall in yield has been linked to the early onset of flowering in sugarcane, which began across many cane-growing regions from January onwards, rather than being confined to only traditional river belts, the associations of sugar mills stated.

"Early flowering — often triggered by abnormal weather patterns, including excess rainfall during key growth phases — accelerates cane maturity and reduces biomass accumulation, resulting in lighter, less productive stalks," ISMA stated.


It has projected that while 3.1 MT sugar will be diverted for ethanol, the net sugar production during the current season is projected at 29.2 MT. The carry forward stock of the sweetener as on October 1, 2026, is projected at 5.3 MT, which will be more than adequate to meet the demand.

The consumption of sugar is projected at 28.3 MT for the current sugar season. India is likely to export 0.7 MT of the sweet-

lion hectare (Mha), compared to 5.71 Mha in 2024-25 season, indicating a marginal increase over last year.

The industry had earlier expressed the concern that a 'small' portion of total requirement for ethanol from sugar-based feedstock for the supply year (ESY) 2025-26 has been allocated by oil marketing companies.

It had stated that only 2,890 million litres of ethanol, just 28% of the total requirement, have been allocated from sugar-based feedstocks for the 2025-26 ESY, compared to 72% or 7,610 million litres from grain-based sources — 4,780 million litres from maize (45%), and 2,830 million litres from rice (22%).

Earlier, the sugar industry also demanded revision of minimum sales price (MSP) of sugar which has remained unchanged at Rs 31/kg since February 2019, while fair and remunerative prices (FRP) has increased by 29% to Rs 355/quintal, which had boosted cost of production to Rs 40.24/kg at present.

Govt plans price support for chana

TO REPLENISH THE buffer and ensure remunerative prices to farmers, the agriculture ministry has approved procurement of 2.3 million tonne (MT) of chana (gram) in Maharashtra, Gujarat, Madhya Pradesh and Rajasthan under the price support scheme (PSS) for 2026-27 rabi marketing season.

The agriculture ministry has approved procurement of 0.76 MT of chana from Maharashtra, 0.58 MT from Madhya Pradesh, 0.55 MT from Rajasthan and 0.41 MT from Gujarat. Last month, under PSS, the ministry approved the purchase of 0.1 MT of chana. Sources said that with arrivals of newly harvested chana in Maharashtra, the market prices are currently ruling 15% to 20% below the minimum support price (MSP) of ₹5,875/quintal for the pulse for the current marketing season.

"The standing crop of chana is progressing well with the beginning of harvesting season. The government's procurement at MSP will support farmer realisation and help maintain price stability during peak arrivals," Harsha Rai, head of Mayur Global Corporation, a leading pulses trading firm, told FE.

Chana output declined to 11.11 MT in 2024-25 after a record harvest of 13.54 MT in the 2021-22 crop year (July-June), leading to prices ruling above MSP for the last couple of years. This led to a drop in buffer stock and the government stopped providing chana under Bharat dal.

The government allowed liberalised imports of yellow peas and bengal gram to meet shortfall in domestic output in the last few years.

Area under chana in the current rabi season has risen over 5.1% to 9.59 million hectares from a year ago. According to government estimates, chana output will be around 11.5 MT in the 2025-26 crop year.

Against a buffer norm of 1 MT, the government currently holds a chana stock of around 0.2 MT. Under the stocking norm, the government needs to hold 2 MT of varieties of pulses aimed at ensuring price stability.

Chana has accounted for nearly 50% of the country's pulses production in the last two seasons.

Procurement by agencies such as Nafed and NCCF is likely to commence from March 15. Procurement of pulses is facilitated through the eSamridhi (NAFED) and aSamyukti (NCCF) portals, with over 1.18 million and 1.6 million farmers registered with the agencies, respectively.

In addition, the ministry has approved MSP purchase of 0.6 MT of masoor (lentil) in Madhya Pradesh.

The government has approved the purchase of 1.3 MT of mustard in Rajasthan and 0.13 MT in Gujarat.

BMC presents ₹81K-cr budget; capex pegged at ₹48,164 cr

THE BRIHANMUMBAI MUNICIPAL Corporation (BMC) on Wednesday proposed a budget outlay of ₹80,952.56 crore for the financial year 2026-27, marking an 8.77% increase over the 2025-26 budget estimate of ₹74,427.41 crore.

BMC Commissioner Bhushan Gagrani tabled the budget in the country's richest civic body, with the capital expenditure pegged at ₹48,164.28 crore, reflecting a rise of about 11.59% over the revised estimate of

₹39,159.51 crore for 2025-26.

The capital outlay in 2025-26 was originally estimated at ₹43,162.23 crore, but was subsequently revised downward.

Revenue expenditure for 2026-27 is proposed at ₹32,698.44 crore, about 15.71% higher than the revised estimate of ₹28,257.91 crore for 2025-26. The revenue expenditure for the current fiscal was initially estimated at ₹31,204.53 crore but later reduced by ₹2,946.62 crore following expenditure rationalisation measures.

The estimated revenue

income for 2026-27 stands at ₹51,510.94 crore, 19.35% higher than the previous budget estimate of ₹43,159.40 crore. The 2025-26 revenue income estimate was later revised upward to ₹46,778.12 crore, an increase of 8.38%.

All available spectrum, across nine frequency bands, should be put to auction in the forthcoming bidding, the telecom regulator recommended.

While the reserve or base price is lower than 2022 auctions for most LSA (Licensed Shared Access) and band combinations, in a few cases, it is higher than the previous sale.
