This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of Yatra Online Ltd.(the company), listed on your stock Exchange.

The Fund under its schemes has carried out sale of 1,60,511 shares of the Company on October 13, 2025. As a result, the shareholding of the Fund has decreased by more than 2% of the paid-up capital of the company as compared to previous disclosure on August 21, 2025 for 5.32%.

It may be further noted that the schemes of the Fund have carried out net sale of 31,76,128 shares of the Company from the last filing submitted on August 21, 2025 (for positions held as on August 20, 2025).

The holding by schemes of the Fund are from an investment perspective and not with the objective of seeking any controlling interest. 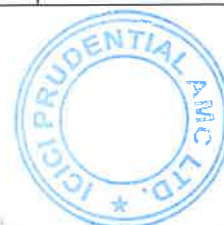
