In this regard, we wish to inform that the Bank has received the approval of the Reserve Bank of India ("**RBI**") vide its letter dated September 09, 2025, for the proposed amendments to the Articles of the Bank in connection with nomination of 2 (two) nominee directors by SMBC and 1 (one) nominee director by SBI, on the board of directors of the Bank, upon completion of the transactions contemplated under the SPA and other relevant agreements. Accordingly, the approval required from the RBI for the amendment to the Articles of the Bank has been received.

Further, the consummation of the transactions contemplated under the SPA and other relevant agreements is subject to customary conditions precedent as mentioned in the agreements referred in our intimation dated May 9, 2025.
