Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is to inform you that YES Bank Limited ("the Bank") has received a communication on May 16, 2025 from the Reserve Bank of India ("RBI") stating that RBI had imposed a monetary penalty of Rs 29.60 Lakh/- (*Rupees Twenty nine lakh sixty thousand only*) on the Bank for non-disclosure of correct and complete information about customer complaints in its Annual Financial Statements for the financial year 2023-24.

This penalty has been imposed in exercise of powers conferred on RBI under the provisions of section 47A(1)(c) read with section 46(4)(i) of the Banking Regulation Act, 1949.

Accordingly, the above information as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Schedule III and the SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123 dated November 11, 2024, is enclosed as *Annexure A*.
