This is to inform you that YES Bank Limited ("the Bank") has received a communication on October 17, 2024, from the Reserve Bank of India (RBI) stating that RBI had imposed a monetary penalty of Rs. 10,000/- on the Bank on account of deficiencies observed during Incognito visit by RBI in one of the Bank's branches.

This penalty has been imposed in accordance with Master Direction DCM (CC) No. G- 3/03.44.01/2023-24 dated April 03, 2023 on "Scheme of Penalties for bank branches including Currency Chests for deficiency in rendering customer service to the members of public".
