# As Trump raises tariffs, Jindal Stainless seeks dumping duty to protect domestic cos

**URGENT ACTION.** Low grade imports, global headwinds putting pressure on margins, says MD

Tariff threats from US President Donald Trump have reignited uncertainty around India-US trade talks, prompting Jindal Stainless MD, Abhyuday Jindal, to call for urgent anti-dumping duties to protect the domestic stainless steel sector from low-grade imports and mounting global headwinds.

A potential shift in the US trade posture, coupled with weakening demand in Europe and a steady inflow of low-grade, non-standard imports into India, has put pressure on margins, with export prospects continuing to be subdued.

"There is uncertainty at the moment on the US...and Europe is subdued until energy issues and UK-Russia tensions subside," Jindal told *businessline*. The search for new markets such as

West Asia, Japan and South American countries is underway. On Wednesday evening (India time), Trump imposed an additional 25 per cent ad valorem duty, over and above the reciprocal tariff of 50 per cent.

**DOMESTIC FOCUS**

However, Jindal Stainless - India's largest stainless steel maker - continues to service "long-standing" US clients, without taking an immediate hit on margins. However, demand in the European region, including key markets,

remains "slow". As a counter measure, the company is maintaining its focus on domestic markets, where it is expanding its presence across sectors including infrastructure, automobiles, defence and aerospace.

The company's domestic-to-export mix stood at 91 to 9 per cent in Q1FY26; in the year-ago period it stood at 90-to-10 per cent.

Jindal said, on the export front, geopolitical uncertainties and protectionist measures in key geographies such as the EU and the US contin-

ued to weigh on sentiments. As against this, the domestic market demonstrated steady growth, with improved demand from sectors such as automotive, metro, white goods, and lifts and elevators.

For the April-June period (Q1FY26), Jindal Stainless reported an over 10 per cent increase in profit after tax (consolidated) to ₹715 crore. PAT in the year-ago period was ₹646 crore. Revenue was at ₹10,207 crore, up 8 per cent y-o-y (₹9,430 crore in Q1FY25). Earnings before interest, tax, depreciation and amortisation (EBITDA) increased 8 per cent y-o-y to ₹1,310 crore.

**ANTI-DUMPING PROBE**

Calling for an urgent need to impose anti-dumping duty on imports from China, Vietnam, Korea and Indonesia, Jindal said there was a need to protect domestic markets and private sector invest-

ments in the stainless steel sector.

Complaints have been filed with the DGTR and the sector is "working closely on many areas of concerns". The complaints were made through the stainless steel industry body, Indian Stainless Steel Development Association (SSDA).

Questions raised by the DGTR have been duly answered, and in all likelihood the probe should start in "another two to three months".

"Protecting our borders is the need of the hour... the situation is urgent," Jindal said.

There has been some moderation in imports with India strengthening BIS standards (or quality control mechanism).

"In the short term, strengthening quality control norms has been a positive towards reducing imports," he added.

# 'Amid tariffs, Made-in-India iPhones to become more expensive for Americans'

US President Donald Trump's announcement to impose a 25 per cent tariff, plus a penalty, on India, effective August 1, will be a big blow to Apple's iPhone customers in the US, analysts said on Wednesday.

"This likely means iPhones will become more expensive for Americans. Even if India gains more production volume, the cost difference between China and India is narrowing," Tarun Pathak, Research Director at Counterpoint Research, told *businessline*.

**SHIFT IN DYNAMICS**

Since iPhones are not yet manufactured in Vietnam, which still has a 20 per cent tariff, the main implication is that unless Apple decides to absorb the extra cost or gets an exemption, it will likely be passed on to consumers, he said. "India has been gaining significant production volume, which is shifting the global dynamics," he added.

Analysts also said that the scope of the penalties could widen, but one has to wait and watch until the details come in the Order.

According to the India Cellular and Electronics Association (ICEA), the overall smartphone manufacturing in India has reached \$64 billion in production in FY25, with exports accounting for 38 per cent to around \$24.1 billion. Smartphone exports have propelled electronics from the seventh-largest export in FY20 to reach the third-largest export in FY25, reaching \$38.6 billion - only behind engineering goods

and petroleum, it added.

**THE BIG FROG**

Major chunk of the total exports goes to the US now, especially through Apple. For instance, in the first five months of 2025, Foxconn has already shipped iPhones worth \$4.4 billion to the US, compared to \$3.7 billion for the entire year of 2024.

Meanwhile, some analysts also said that there won't be much impact since US tariff on Chinese imports is 30 per cent, which is just a 5 per cent difference from India's 25 per cent now.

"It is not a significant gap between the two though the prices will go up for iPhones, whether imported from India or China. It might slow down a bit initially, but there is no other option. Earlier the risk was, since there was probably a good differential, so it (Apple) could go to any country, but now it is kind of harmonised. So, its unlikely that it would move out of China or India for that matter," Faisal Kawoosa, Chief Analyst and Founder of Techarc, told *businessline*.

# Bharat Forge Q1 results resilient amidst export headwinds

Bharat Forge Ltd, a global leader in engineering and manufacturing, announced its unaudited financial results for the first quarter ended June 30, 2025 (Q1 FY26), demonstrating resilience despite challenging conditions in the export markets.

The performance was supported by robust domestic demand and strategic order wins. On a standalone basis, the company reported revenue of ₹2,105 crore, marking a 2.7 per cent decline quarter-on-quarter. EBITDA stood at ₹588 crore, with a healthy margin of 27.9 per cent. Profit before tax (before exceptional items) came in at ₹465 crore, while profit after tax was at ₹339 crore.

During the quarter, Bharat Forge secured new orders worth ₹847 crore, including ₹269 crore in the defence sector. The company's defence order book now stands at ₹9,463 crore. On a consolidated basis, the company reported revenue of ₹3,909 crore. EBITDA was ₹682 crore, reflecting a margin of 17.5 per cent, and profit before tax (before exceptional items) was ₹423 crore.

In domestic business, passenger vehicle and industrial segments performed strongly while defence execution remained robust. Exports declined 12.7 per cent q-o-q; North America was impacted by emission norm rollback and policy flux. Europe showed early signs of recovery. CV exports to Europe saw some revival post the lows seen last year.

Strong performance of Hindi and Hollywood flicks at the box office enabled PVR INOX to sharply narrow down consolidated net loss to ₹54 crore in the June quarter compared to ₹179 crore in the corresponding quarter in the previous fiscal. Consolidated revenue from operations grew 23.3 per cent to ₹1,469.1 crore. The quarter saw 10 films crossing the ₹100 crore-mark and three films crossing the ₹200

# PVR INOX narrows net loss to ₹54 cr in June aided by box office hits

crore mark in box office collections.

**NEW SCREENS**

Ajay Bijli, Managing Director, PVR INOX, told *businessline* that multiple films doing well at the box office signals a healthier theatrical environment. "The consistent performance of movies across genres and languages during the June quarter signals healthier theatrical environment, where performance is less skewed by mega blockbusters and more anchored in the sustained

strength of mid-to-high performing titles. It also dispels the myth that consumers will only come to see the big budget movies," Bijli added.

In line with its capital-light strategy, the leading multiplex chain has opened 20 new screens during the quarter of which 14 were under FOCO (Franchisee-owned company operated) model.

"We have signed 127 screens under the capital light models across 29 cinemas. Of this 55 screens in 14 cinemas will be under

FOCO model, while 72 screens across 15 cinemas will be set up under asset-light model. Most of these cinemas will come up in the next 12-24 months," Bijli explained. In FY26, it plans to add 90-100 new screens, of which 24 screens have already been launched.

**CONSUMER CHOICES**

"The content pipeline for Q2 and the remainder of FY26 is looking very strong with a strong mix of Hindi, regional and Hollywood releases. We are optimistic that this mo-

mentum will continue driven by high consumer demand, strong content slate, and continued recovery in urban and tier 2/3 markets," Bijli added.

He added that the company is strongly focusing on strengthening its bottom line through various cost efficiency initiatives. Bijli said that the company is also focusing on revenue maximisation strategy by offering movies at various price points and screening alternate content to boost admissions.

# Subdued demand slows down Trent's Q1 growth

Tata group owned Trent Ltd's net profit growth in the first quarter of FY26 slowed to its lowest in two years as subdued demand bit into its topline.

The retailer, which operates apparel chains such as Westside and Zudio, reported a net profit of ₹430 crore, up 9.5 per cent on year while revenue was 19 per cent higher at ₹4,884 crore.

During the quarter like-for-like growth, a key performance metric, for its fashion portfolio was in low single digits, it said, adding that despite the onset of early monsoons and geopolitical disruptions, the growth in revenues across micro markets was healthy.

It opened 12 stores during the quarter, ending with a store count of 1,043, it said.

It is also expanding its presence across tier-2 and -3 cities. "Many of these markets are still emerging in terms of adoption of fashion trends and density of consumption," but they afforded substantial opportunities, though they would evolve to maturity over different time horizons.

Margin profiles of Westside and Zudio were consistent, it said while emerging categories such as including beauty & personal care, innerwear and footwear contributed to over a fifth of its revenues.

Online revenues grew 35 per cent and contributed to over 6 per cent of Westside revenues.

Its hypermarket chain Star Bazaar added 2 new stores in the quarter while three stores were closed.

"We are pursuing multiple interventions including on the technology front aimed at driving differentiation and convenience of our customer proposition," it said.

"The opportunity in the food space for the Star proposition is exciting while being competitive. We remain convinced that this business is well poised to deliver much consumer value and growth in the years ahead," said Chairman Noel Tata.
