**Sub: Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”)**

Dear Sir/ Madam,

With reference to our earlier communication dated **February 25, 2025**, we wish to inform you that Zinka Logistics Solutions Limited ("**the Company**") had filed an application dated March 21, 2025, seeking rectification of an error apparent from the record in the income tax assessment order for the Assessment Year 2019–20. Pursuant to the said application, the Company has received a modified order dated July 14, 2025 (Letter No. ITBA/COM/F/17/2025-26/1078445423(1)), issued under Section 154 of the Income Tax Act, 1961 from the Income Tax Department, Government of India, revising the earlier tax demand. As per the revised order, a tax demand of INR 91.20 lakhs (including interest) has been determined, as against the earlier demand of INR 4.18 crores, which was raised for default in respect of short deduction/non-remittance of TDS. The Company is currently evaluating the implications of this modified order on its financial statements.

We believe that we have a strong case on merits. The Company will be filing an appeal/revision against the order before the appropriate authority.

The details of order as required under Regulation 30 of the Listing Regulations read with SEBI circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13 July 2023 is enclosed herewith as **Annexure - I**.
