Much awaited Amitabh Bachchan starrer 'Chehre' in theatres



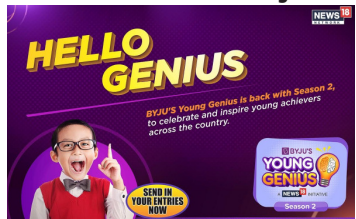

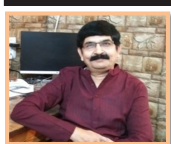
