Pursuant to Regulation 30 of the Listing Regulations, we wish to submit that Zomato Netherlands B.V. ("**Zomato Netherlands**"), step down subsidiary of Eternal Limited (Formerly known as Zomato Limited) ("**the Company**") situated in Netherlands has initiated the process of liquidation w.e.f. April 9, 2025.

Further, as disclosed in our red herring prospectus dated July 6, 2021 and prospectus dated July 19, 2021, Zomato Netherlands does not have any active business operation.

It may be further noted that Zomato Netherlands is not a material subsidiary of the Company, and the dissolution of Zomato Netherlands will not affect the turnover/revenue of the Company.
