We would like to inform you that Eternal Limited ("**the Company**") has received the following communications today, that:

- a. Zomato Media (Private) Limited, ("**ZMPL**") wholly owned subsidiary of the Company, located in Sri Lanka will be struck off from the register of companies and dissolved at the expiration of three months from the date of gazette notification i.e. November 21, 2025; and
- b. Zomato Internet Hizmetleri Ticaret Anonim Sirketi ("**ZIHTAS**"), step down subsidiary of the Company, located in Turkey has been liquidated w.e.f. December 9, 2025.

Further, as disclosed in our red herring prospectus dated July 6, 2021 and prospectus dated July 19, 2021, **ZMPL** and **ZIHTAS** do not have any active business operations and are under the process of liquidation.

It may be further noted that **ZMPL** and **ZIHTAS** are not material subsidiaries of the Company and the dissolution of **ZMPL** and **ZIHTAS** will not affect the turnover/ revenue of the Company. The details as required under Listing Regulations read with SEBI master circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, for **ZMPL and ZIHTAS** are given in **Annexure A** and **Annexure B** respectively.
