Pursuant to Regulation 30 and other applicable provisions of the Listing Regulations read with SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (“**SEBI Circular**”), we wish to inform you that a) Blink Commerce Private Limited (“**BCPL**”), a wholly owned subsidiary of Eternal Limited (Formerly known as Zomato Limited) (“**Company**”); and b) Blinkit Foods Limited (“**BFL**”), another wholly owned subsidiary of the Company have entered into business transfer agreement (“**BTA**”) wherein the quick food service business operated under the brand ‘Bistro by Blinkit’ (“**Bistro Business**”) shall be transferred from BCPL to BFL for internal restructuring purpose, for an aggregate consideration of INR 57,00,00,000 (Indian Rupees Fifty Seven Crores Only), by way of slump sale, on a going concern basis subject to the adjustments as agreed under the BTA.
