

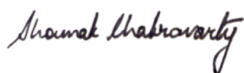

Note 1: During the quarter ended June 30, 2025, one of the fixed deposits of Rs 3.00 crore matured, and the proceeds were transferred to its cash credit account. The proceeds received from conversion of warrants to equity shares of Rs 12.85 crore were also transferred to the Company's cash credit (CC) account for further utilization due to operational ease. For utilization of proceeds towards Object 1 of the issue, the Company had transferred funds from the CC account to the current account of its subsidiary. As at the end of the reported quarter, balance of Rs 1.10 crore were lying as a balance in the CC account of the Company.

Note 2: During the reported quarter, the Company had incurred expenses of Rs. 0.65 crore for the expansion of Davaindia project and the same was financed through Cash Credit facilities from the ICICI Bank. However, the said expenses of Rs. 0.65 crore were later reimbursed from the issue proceeds of Preferential Issue during the reported quarter.

Note 3: Out of the issue proceeds of Rs 179.07 crore, the Company has received issue proceeds of Rs 109.08 crores till the quarter ended June 30, 2025. Out of the received proceeds, Rs 104.98 crore is utilized till the reported quarter and unutilized amount of Rs 3.00 crore is parked in FDs and a balance of Rs 1.10 crore is lying in CC account of the Company. The balance amount Rs 69.99 crore is expected to be received by the warrant holders at the time of exercising the conversion rights, on or before the expiry of 18 (eighteen) months from the date of allotment of the Warrants as per the Notice to Shareholders dated July 13, 2024.
