OPENED 50 COMPANY OWNED COMPANY OPERATED (COCO) STORES OF DAVAINDIA BY DAVAINDIA HEALTH MART LIMITED, WHOLLY OWNED SUBSIDIARY OF THE COMPANY

SURAT, September 19, 2022: Zota Health Care Ltd (NSE: Zota): M/s Davaindia Health Mart Limited, the wholly-owned subsidiary of the Company (herein after “WOS”) has opened 50th Company Owned Company Operated (COCO) store of DAVAINDIA. It is the first kind of store variant in India which will have huge store space of between 800-1400 sq. feet and offers Generic, Ayurvedic, Nutraceutical and OTC products under the same roof. In COCO store, WOS offering ~1650 SKUs and around 95% of which are private labeled, highest numbers of private labeled SKUs by any generic pharmacy chain in India. DAVAINDIA is a generic pharmacy chain which provides high quality generic medicines at a very low cost as compared to branded counter parts.

Further, in Franchisee Owned Franchisee Operated (FOFO) stores of DAVAINDIA we are continuously augment our network. By larger store network of 551 FOFO stores we already have marked our presence in 25 states of India.”*
