SUMMARY OF PROCEEDINGS OF THE EXTRA-ORDINARY GENERAL MEETING OF THE COMPANY HELD ON SATURDAY 25TH JANUARY, 2025 FROM 11:30 A.M. TO 12:21 P.M. THROUGH VIDEO CONFERENCE.

Date, Time and Venue of the Extraordinary General Meeting

The Extra-ordinary General Meeting ("EOGM" or "Meeting") of the Company was held on Saturday, January 25, 2025, through Video Conferencing ("VC") in accordance with the applicable provisions of Companies Act, 2013 read with the Rules issued thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the circulars issued by Ministry of Corporate Affairs and the Securities and Exchange Board of India.

Proceedings in brief:

Mr. Ashish Goel, Company Secretary & Compliance Officer of the Company informed the members that the meeting is being held through video conferencing in accordance with the circulars and guidelines issued by MCA and SEBI.

Mr. Goel welcomed the Shareholders to the EOGM of the Company and introduced the Directors and other invitees present in the meeting.

Ms. Sanghamitra Borgohain, Chairperson & Managing Director of the Company, occupied the chair and welcomed all the Members and invitees present at the meeting and conducted the proceedings of the EOGM.

The Chairperson confirmed that requisite quorum was present and called the meeting to be in order.

The chairperson informed that the company had enabled the members to participate at the EOGM through VC facility provided by CDSL and the proceedings are being recorded for compliance purposes. She further informed that the members had been provided the facility to exercise their right to vote by electronic means, both through remote e-voting and e-voting during the EOGM and the members who are present at the EOGM and had not cast their vote through remote e-voting, has been provided an opportunity to cast their votes through e-voting at the meeting. In this regard, the Board of Directors have appointed M/s Rawal & Co. Practising Company Secretary as the Scrutinizer to conduct the remote e-voting and e-voting process at the EOGM.

Chairperson further informed the purpose of the meeting is to seek approval of members for the increase in authorised share capital of the Company and proposed preferential issue of shares and warrants convertible into share. She outlined the reasons for the preferential issue, which included strengthening the financial position, funding strategic initiatives (such as capital expenditures in theme parks and Unidentified acquisition of landscaping & water treatment company), and enhancing shareholder value.

Thereafter Ms. Sanghamitra Borgohain requested to Mr. Pradeep Sangwan, Non -Executive Non- Independent director to proceed further with the meeting.

Mr. Pradeep Sangwan confirmed that the notice dated 26th December 2024 and the corrigendum dated 16th January 2025 have been circulated to the members is taken as read.

Mr. Sangwan, further informed that the members who had not yet cast their vote could do so within the next 15 minutes, after which the voting facility would be disabled by CDSL. He further noted that as no shareholder had registered to ask questions or express views during the meeting, he proceeded with the agenda.

He informed to the shareholders that the results of the e-voting, along with the scrutinizer's report, would be announced within two working days of the meeting and published on the company's website, NSE Limited, and CDSL's website.

He further, thanked all the members for giving their presence in the meeting.

There being no other business the meeting concluded with a vote of thanks to the Chair.
