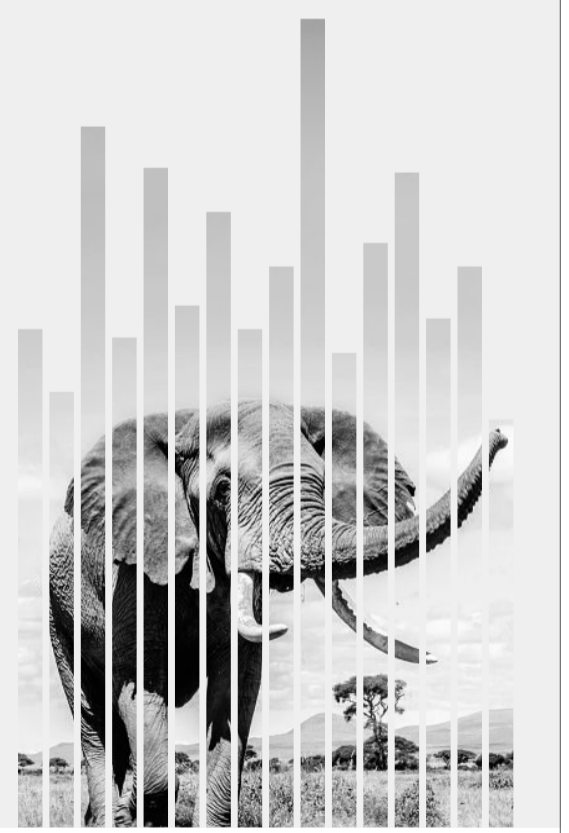

फर्दिन रिबेलो : टीसीपीचे कलम ३९ ए रद्दची मागणी, सर्व अर्जांचा सर्वेक्षण पुनर्विचार करणे आवश्यक

पणजी : निवृत्त न्यायमूर्ती फर्दिन रिबेलो यांच्या 'इनफ इज इनफ' चळवळीने नगर नियोजन कायद्यातील कलम ३९ ए रद्द करण्याची तसेच कलम १५(२) आणि १७ अ अंतर्गत प्रक्रियेत आलेल्या सर्व अर्जांचा सर्वेक्षण पुनर्विचार करण्याची मागणी पुन्हा एकदा केली आहे.

संघटनेचे समन्वय न्यायमूर्ती रिबेलो यांनी प्रसिध्दी पत्रकत असे म्हटले आहे की, 'नगर नियोजन मंडळ आणि गोवा सरकारकडून विकासक व बिल्डिंगराना लाभ मिळावा यासाठी अधिकारांचा बेकायदेशीर आणि मनमानी वापर होत

असल्याने राज्यातील नागरिक आवाज उठवत आहेत. राज्यात विविध ठिकाणी आंदोलने होत असताना कारापूर येथील नागरिकांचा लढा ठळक ठरला आहे. कारापूरमधील रहिवासी त्यांच्या शेतजमिनी, उपासनेची स्थळे, तसेच गावे, जलस्रोत आणि नैसर्गिक अधिवास यांचे संरक्षण करण्यासाठी लढा देत आहेत. मोठ्या प्रमाणावर निवासी प्रकल्प उभारल्यास पाणी, वीज, रस्ते यांसारख्या मूलभूत सुविधांवर ताण येईल, तसेच आवश्यक वहन क्षमता अभ्यास न करता केलेल्या जमिनीच्या रूपांतरणामुळे मातीची गुणवत्ता घटेल, अशी त्यांची चिंता आहे.

काही हितसंबंधांना प्राधान्य दिल्याचा आरोप

न्यायमूर्ती रिबेलो यांनी पुढे असे म्हटले आहे की, 'या जमिनीच्या विकाससाठी नगरनियोजन कायद्याच्या कलम १७(२) आणि ३९ ए अंतर्गत मंजूरी देण्यात आल्याचा आरोप आहे. काही विशिष्ट हितसंबंधांना प्राधान्य दिले जात असल्याचे दिसते. कलम ३९ ए नुसार अर्जावर सर्वेक्षण सूचना, हरकती व सूचना मागवून त्यांचा विचार करणे आवश्यक आहे.

नगर नियोजन मंडळ सार्वजनिक हरकती नाकारण्यामागील कारणे जाहीर करत नाही आणि शेट परवानग्या मंजूर केल्या जातात. या पारदर्शकतेच्या अभावावर चळवळीने प्रश्नचिन्ह उपस्थित होत असून हरकती का नाकारल्या जातात याची कारणांमार्फत सार्वजनिक का केली जात नाही, असा सवाल रिबेलो यांनी केला आहे.

३ ही चळवळ कारापूरमधील नागरिकांच्या जीवन, उपजीविका आणि ओळख जपण्यासाठीच्या लढ्याला पाठिंबा देत असून, त्यांनी कथित बेकायदेशीर कारवायांविरुद्ध उभारलेल्या आंदोलनालाही समर्थन दर्शवते, असे रिबेलो यांनी म्हटले आहे.

४ अंतिम न्यायालयीन निर्णय ईश्वरपर्यंत नवीन मंजूरी देण्यास टाळाटळा करणे आवश्यक असल्याचे त्यांनी शेवटी नमूद केले आहे.
