Notes:

1. The Hon'ble National Company Law Tribunal (NCLT), Allahabad Bench, Prayagrah, admitted the petition filed by Oriental Bank of Commerce (OBC) for winding up of the Company under Section 233 of the Companies Act, 2013 and directed the Company to file a plan of revival or reconstruction of the Company within a period of 90 days from the date of the order dated 11.07.2024 and reported Mr. Anurag Goel as the Interim Resolution Professional (IRP). The Hon'ble National Company Law Appellate Tribunal (NCLAT), vide its judgment dated 13.07.2026, dismissed the appeal filed by M/s. Gurinam Kaur Mann and directed the appeal filed by M/s. Gurinam Kaur Mann (Farmers) with certain directions. Subsequent to the judgment by the Hon'ble NCLAT dated 13th July 2026, Appeals were filed before the Hon'ble Supreme Court of India by Suspendent Board of Directors, through M/s. Gurinam Kaur Mann (Promoter) and Farmers in relation to the said NCLAT Judgment. The interrelated appeal was disposed of as dismissed by the Hon'ble Supreme Court vide its order dated 07th August 2026. Accordingly, the CIRP of the Company continues in accordance with the applicable provisions of the IRC.

2. In view of the above, the financial results for the quarter ended 30.06.2026 have not been considered and recommended by the Audit Committee and consequently by the Board of Directors. The said financial results have been certified by the Chief Financial Officer and have been taken on record by the IRP on 12 August 2026 solely for the purpose of ensuring compliance by the Corporate Debtor with applicable provisions of the Insolvency and Bankruptcy Code, 2016 (IBC) and subject to the following disclosures (Refer Note to Accounts no. 20 in the Financials available on Company's website www.simbhaolisugars.com)

3. The financial results have been taken on record by the IRP on good faith accordingly, no suit, prosecution or other legal proceeding shall lie against the IRP in terms of Section 233 of the Code.

4. The IRP, while taking the financial results on record, has relied upon the certifications, representations and information provided by the Key Managerial Personnel, management and officials of the Company and the review conducted by the Statutory Auditors. Accordingly, the IRP does not assume responsibility for the accuracy, veracity or completeness of such information.
