Sub: Clarification/Confirmation on news article captioned “NALCO eyes 200-300 MW green power capacity backed by battery storage for low-carbon aluminium”.

Referring to your e-mails dated 27.01.2026 regarding news clarification on news article titled, “NALCO eyes 200-300 MW green power capacity backed by battery storage for low-carbon aluminium”, following clarifications are submitted:

Query (a) Whether such negotiations/events were taking place? If so, you are advised to provide the said information along with the sequence of events in chronological order from the start of negotiations/events till date.

Reply: No negotiations/events in connection with setting up of 200-300 MW green power capacity backed by battery storage for low-carbon aluminium has taken place as on date.

However, NALCO is in process of appointing a Consultant for Renewable Energy (RE) transition to meet its present and future RE obligation.

Query (b) Whether you/company are aware of any information that has not been announced to the Exchanges which could explain the movement in the trading, if any? Further, you are advised to provide the said information and the reasons for not disclosing the same to the Exchange earlier as required under regulation 30 of the SEBI (LODR) Regulations, 2015.

Reply: NALCO is not aware of any information that has not been announced to the Exchanges which could explain the movement in the trading.

It would be appreciated that, the price movement of all non-ferrous metal stocks are in upwards trend in last couple of trading sessions and NALCO is not an exception in this regard.

Query (c) The material impact of this article on the Company.

Reply: As stated above, there is no material impact of the aforesaid news on the Company.
