The Hon'ble NCLT, Kolkata bench has passed an order under section 31 (1) of the Insolvency and Bankruptcy Code on September 4, 2019 ("Order"), approving the resolution plan for Ramsarup Industries Limited submitted by the consortium of SS Natural Resources Private Limited and Shyam SEL & Power Limited. The Order has been appealed against by certain stakeholders in NCLAT and the matter is sub-judice.
