This is further to our intimation dated November 27, 2025, submitted pursuant to Regulation 29(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, as amended, regarding the acquisition of 1,01,194 equity shares of ₹1/- each of Roto Pumps Limited (“the Company”) through open market purchases by Mr. Harish Chandra Gupta, Harish Chandra Gupta HUF, Ms. Neera Gupta and Ms. Gaisu Saluja, belonging to the Promoter and Promoter Group of the Company.
