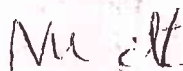
By way of background, First State Investments is part of the asset management division of the Commonwealth Bank of Australia, one of Australia's largest financial institutions.

We act as investment manager to both segregated and pooled clients, with a particular focus on Asia Pacific and Global Emerging Markets equities. As part of these strategies, our fund managers have sold parts of their interests in EID Parry India Limited, in which we have decreased our holdings by more than 2% from the previous filing made on the 3rd July 2014 (7.617%). The settlement date of the transactions decreasing our holdings above the 2% threshold to 5.601% was 11th September 2014.
