राहुरी, (वार्ताहर) : राहुरीकरांना निवडणुकीत दिलेला शब्द पाळला. नगर-मनमाड हायवे ते संत महिपती महाराज चौक (कोर्ट रोड) या महत्त्वाच्या रस्त्यासाठी निधी मंजूर होऊन वर्ष उलटले तरी प्रशासकीय पातळीवर काम रखडले होते. आम्ही सातत्याने पाठपुरावा करून प्रशासनाकडे टेंडर प्रक्रिया राबवण्याची मागणी केली. अखेर नागरिकांचे हाल थांबवण्यासाठी या रस्त्याच्या डॉबरीकरणाला सुरुवात होत असून, निवडणुकीत दिलेला शब्द पाळल्याचा मला आनंद आहे, असे प्रतिपादन माजी मंत्री प्राजक्त तनपुरे यांनी केले.

वाळू वाहतुकीच्या आरोपातून दोघे निर्दोष

राहुरी, (वार्ताहर) : राहुरी शिवारात नगर-मनमाड रस्त्यावर दिनांक ११ एप्रिल २०१९ रोजी वाळू चोरीच्या प्रकरणात भरण्यात आलेल्या खटल्यातील आरोपी महमंद हुसेन शेख व युनूस निसार शेख यांची राहुरी न्यायालयाने सबळ पुराव्याअभावी निर्दोष मुक्तता केली. या खटल्यात आरोपीतर्फे अॅड. प्रकाश संसारे यांनी काम पाहिले. सात वर्षांपूर्वी म्हणजे ११ एप्रिल २०१९ रोजी दोन्ही आरोपी मुळा पात्रातून बेकायदा वाळूची वाहतूक करताना आढळून आले. पोलिसांनी पंचनामा करून त्यांच्याविरुद्ध न्यायालयात खटला पाठविला होता. त्याची सुनावणी ६ फेब्रुवारी २०२६ रोजी होऊन आरोपींची पुराव्याअभावी निर्दोष मुक्तता करण्यात आली.

लव्ह जिहाद व धर्मांतरविरोधी कायद्यासाठी शासनाला स्मरणपत्र

राहुरी, (वार्ताहर) : लव्ह जिहाद विरोधी आणि धर्मांतरण विरोधी कायद्यासाठी प्रशासनाने घेतलेल्या निर्णयाला एक वर्ष झाले. तरी प्रशासनाकडून कोणतीच कारवाई झाली नाही. त्यामुळे प्रशासनाला पुन्हा स्मरण करून देण्यासाठी शुक्रवारी (दि. १३) राहुरी येथील सकल हिंदू समाजाच्यावतीने प्रशासनाला निवेदन देण्यात आले. तहसीलदार अमित पवार यांना दिलेल्या निवेदनात म्हटले आहे की लव्ह जिहाद, फसवणूक करून किंवा बलपूर्वक करण्यात येणारे धर्मांतर रोखण्याच्या अनुषंगाने कायदेशीर बाबींचा अभ्यास करण्यासाठी विशेष समिती गठीत करण्याचा निर्णय प्रशासनाने दि. १४ फेब्रुवारी २०२५ रोजी घेतला होता. सदर समितीच्या माध्यमातून राज्यातील परिस्थितीचा अभ्यास करणे, प्राप्त तक्रारींचा आढावा घेणे, इतर राज्यातील कायदांचा अभ्यास करणे व आवश्यक असल्यास कायद्याचा मसुदा तयार करणे अपेक्षित होते. मात्र शासन निर्णयास एक वर्षापेक्षा अधिक कालावधी लोटूनही अद्याप कोणतीही ठोस कार्यवाही, अहवाल, शिफारस अथवा कायद्याच्यादृष्टीने पुढील निर्णय झाल्याचे निर्दर्शनास येत नाही, असे निवेदनात म्हटले आहे.
